Dear Colleagues,

The OSCE Parliamentary Assembly played a leading role in the observation of the first and second round of the Presidential Election in Ukraine, both of which failed to meet a significant number of OSCE commitments and failed to result in the election of a new President of Ukraine.

Following a decision of the Supreme Court, a re-run of the second round of the election has been scheduled for 26 December. This latest phase of the election process has a historic significance for Ukraine and for the region and it is of the utmost importance that they produce a result that reflects the will of the Ukrainian people. International observers have a key role to play in this process. The OSCE PA will observe these elections and will closely cooperate, as before, with the PACE, EP, NATO PA, the ODIHR and other international observation missions.

I invite you to join this most important mission. The deadline for registration is 15 December. A registration and accreditation form is attached. Further questions can be addressed to Spencer Oliver, Secretary-General, or Paul LeGendre, Programme Officer at the International Secretariat in Copenhagen.
