Kære Ida Heide-Jørgensen,

Amnesty International i Danmark giver i et brev af 19. oktober 2004 vedrørende Xiaotian Liu, klart udtryk for hvilke farer og katastrofale følger han risikerer ved en tilbagesending til Kina. Amnesty International udtrykker klart at hans liv vil være i direkte fare, hvis dette skulle blive en realitet.

Jeg ønsker desuden at gøre opmærksom på organisationen "Den Globale Mission for at Redde Forfulgte Falun Gong-udøvere" (Global Mission to Rescue Persecuted Falun Gong Practitioners, GMRPFP), som Amnesty International bl.a. henviser til i sit brev samt bilag om forfulgte børn af Falun Gong-udøvere. Denne hjemmeside omhandler specielt børn, som har været utsat for forfølgelsen af Falun Gong eller er blevet forældreløse som følge af forfølgelsen. Adressen er: <http://www.rescueflgchildren.org>. Xiaotian Liu's historie, der er den første af sin slags om en forældreløs dreng, der er flygtet til udlandet fordi begge hans forældre er blevet tortureret ihjel, behandles også på denne hjemmeside. Xiaotian's sag er et meget vigtigt og centrale eksempel på de grusomheder uskyldige børn utsættes for af de kinesiske myndigheder blot pga. at de selv udøver Falun Gong eller er beslægtet med Falun Gong-udøvere. Dette nævnes også i Amnesty International's brev af 19. oktober 2004 samt i deres seneste rapporter vedr. forfølgelsen af Falun Gong i Kina.

Endvidere vil jeg gerne introducere en 8 minutter lang film "*Rescuing Falun Gong Children in China*", som jeg har vedlagt på CD-ROM. Her er Xiaotian's historie også blandt de omtalte sager.

At værne om og hjælpe børn af Falun Gong-udøvere er noget der i øjeblikket har mange menneskers interesse. Jeg håber at De efter at have kigget nærmere på vedlagte materiale samt filmen "*Rescuing Falun Gong Children in China*", vil få et dybere kendskab til hvilke smertefulde lidelser børn af Falun Gong-udøvere dagligt gennemlever, og dermed hvilken frygtelig skæbne der venter Xiaotian Liu, hvis han udvises tilbage til Kina.

EFGIC: Rescue Mission Turns to Chinese Children International organization campaigns to rescue the children of persecuted Falun Gong practitioners in China

LONDON [EFGIC]— Along with the verified death toll of 1,099 Falun Gong practitioners has come the suffering of countless children in China. An international organization is now working to bring those children out of China to a warm home.

Five-year-old Rongrong is the kind of child this mission is aiming to help. The girl's father was tortured to death because he practised Falun Gong and her mother was later arrested. Her grandmother soon died of grief, leaving only the grandfather to take care of her.

Another case is that of Yang Kai, 12, and Yang Hang, 11. Police had abducted their mother from their home for practising Falun Gong, and she was killed within six months. With father Yang Zhanjiu

serving a seven-year sentence, and with the grandmother abducted six times and tortured for supporting Falun Gong, the two boys were left with the grandfather to take care of them.

To help children like these, the Global Mission to Rescue Persecuted Falun Gong Practitioners ([website](#)) is collecting and organizing cases in which Chinese children became orphans or lost parents due to Jiang Zemin's persecution of Falun Gong in China. The organization has issued an initial report ([report](#)) and is working with other NGOs to open up channels that will allow these children to be received in safe countries.

Dr. Elizabeth Wang, the Global Mission's director, says, "In addition to losing their family and the care required for their age, these children have also lost their dignity as human beings. They've been discriminated against and viciously defamed in society, in schools, and even in kindergartens. They were labelled as bad kids, or the kids of bad people."

The international organization, with branches in 16 countries, has also documented cases in which children have had to watch the abuse and beating of their parents.

For instance, in July 2000, as two-year-old Wang Shujie was being fed by her mother, police officers broke into her home and abducted all the adults. A few months later, the infant watched as police hit her father across the face with a book during interrogation. She immediately passed out. After regaining consciousness she began sweating and had a fever. She swayed from side to side and became restless, banging her head against the wall. She stopped growing and stopped eating, became skin and bones, and died in July 2002.
