Progress report of the Bureau of the Assembly and of the Standing Committee (29 April – 20 June 2005)

1. INTRODUCTION

1. The Bureau met on 29 April in Strasbourg, on 6 June in Lisbon and on 20 June in Strasbourg. The Standing Committee met on 6 June in Lisbon.

2. FUNCTIONING OF THE ASSEMBLY

39. On 6 June, the Bureau approved the current composition of the ad hoc Committee to observe these elections being understood that it may change when the date of the election will be announced and appointed Lord Russell-Johnston (LDR) as Chairperson.

D. ELECTIONS IN NAGORNO KARABAKH (19 JUNE 2005)

40. On 6 June, the Bureau decided not to observe these elections.

E. PARLIAMENTARY ELECTIONS IN AZERBAIJAN (NOVEMBER 2005)

- 41. On 20 June, the Bureau:
 - set up an Ad hoc Committee to observe the parliamentary elections in Azerbaijan composed of 40 members (d'Hondt system: SOC: 14; EPP/DC: 13; LDR: 6; EDG: 5; UEL: 2);

decided that a pre-electoral mission should take place one month before the election at the latest, composed of five members, one from each political group who are at the same time members of the Ad Hoc Committee.

8. OTHER MATTERS

A. FOLLOW-UP TO THE THIRD SUMMIT OF HEADS OF STATE AND GOVERNMENT OF THE COUNCIL OF EUROPE (WARSAW. 16-17 MAY 2005)

- 42. On 6 June, the Bureau:
 - > held an exchange of views on this matter;
 - asked the President to send a letter to the Chairperson of the Committee of Ministers informing him about concrete proposals of the Assembly concerning the implementation of the Action Plan adopted at the Third Summit, in particular the involvement of the Assembly in the appointment of the group of wise persons for the reform of the European Court of Human Rights and the setting-up of the Council of Europe Forum for the Future of Democracy;
 - decided that the Presidential Committee will be responsible within the Assembly to follow closely the implementation of the Action Plan of the Third Summit.

B. IMMUNITIES OF ASSEMBLY MEMBERS

- 43. On 29 April, the Bureau:
- i. took note that the Committee on Rules of Procedure and Immunities had decided to close the procedure concerning Mr Iannuzzi's request for the defence of his immunity as a member of the Assembly:
- ii. asked the Committee on Rules of Procedure and Immunities to prepare a report on the interpretation of Article 15 of the General Agreement on privileges and immunities of the Council of Europe.

C. OFFICIAL REPORTS OF ASSEMBLY DEBATES

- 44. On 29 April, the Bureau postponed the consideration of this matter to one of its next meetings.
- 45. On 6 June, the Bureau took note of the memorandum prepared by the secretariat and decided to come back to this matter at a next Bureau meeting.

D. EXHIBITIONS IN THE ASSEMBLY LOBBY DURING PART-SESSIONS

46. On 29 April, the Bureau approved the draft decision contained in the memorandum on this matter (Appendix II).

E. STEPPING UP INTERNAL SECURITY IN THE PALAIS DE L'EUROPE BY EXTENDING THE ACCESS CONTROL SYSTEM

47. On 29 April, the Bureau took note of the proposals contained in the memorandum on this matter;

48. On 20 June, the Bureau took note of the letter of the Chairman of the Political Affairs Committee informing the Bureau about the discussions in this committee concerning a possible fact-finding visit to the Chechen Republic.

EXHIBITIONS IN THE ASSEMBLY LOBBY

Secretariat Memorandum prepared at the request of the President

Introduction

1. Guidelines for the organisation of exhibitions in the Assembly Lobby during sessions were adopted by the Bureau on 13 January 1997 (see appended doc. AS/Bur (1996) 126 rev). However, these appear to require some clarification in the light of practice.

Draft decision

- 2. The Bureau reaffirms its decision of 13 January 1997 regarding the organisation of exhibitions in the Assembly Lobby during sessions, while specifying that:
- a) requests for authorisation must be submitted to the President of the Assembly by chairpersons of parliamentary delegations or committees at least three months in advance of the opening of the part-session to which the request relates;
- b) exhibitions requested by parliamentary delegations or committees must be directly related to the work of the Assembly;
- c) previously authorised requests from parliamentary delegations or committees for the mounting of exhibitions must be taken into account in order to ensure a fair distribution of opportunities to all delegations and committees.

EXHIBITIONS DURING ASSEMBLY SESSIONS

Note by the Office of the Clerk prepared on the instructions of the President of the Assembly

Background

- 1. At the September 1996 Session the President heard complaints that it was difficult to find a place to sit in the Assembly's lobby, because the space in front of the sofas was taken by exhibition panels.
- 2. It is true that the number of exhibitions in the Palace of Europe during Assembly sessions has been growing.
- 3. In addition, the organisers often prefer the Assembly's lobby to other places in the building, because they wish to ensure that Members of the Assembly see their exhibitions.
- 4. Authorisation of exhibitions in the Committee of Ministers' lobby is given by the Bureau of the Ministers' Deputies. For using other places in the building, when the Assembly is not sitting, the Secretary General gives his approval.
- 5. Therefore, guidelines from the Bureau on organising exhibitions <u>during sessions</u> would be welcomed.

Decision

- 6. The Bureau decided to free the Assembly's lobby from all exhibitions, except for exhibitions requested by parliamentary delegations or committees who wish to illustrate their activities, eg the Museum Prize.
- 7. All other exhibitions during sessions could, after informing the President, be arranged by the Secretary General in other suitable parts of the building.
- 8. During a transitional period, the President will honour authorisations already granted to use the lobby.
