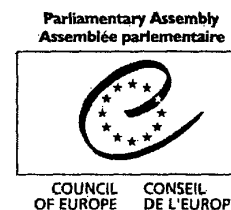

Examination of credentials of Representatives and Substitutes

Supplementary report
presented by the President of the Assembly

1. Following the examination of credentials of new representatives and substitutes appointed at the 3rd part of the 2005 session of the Assembly, credentials certified by the competent authorities of four member states have been transmitted to the President of the Assembly for validation by the Standing Committee acting on behalf of the Assembly.
2. Following parliamentary elections, *Moldova* has appointed two new representatives to replace MM. Cosarciuc, Prijmireanu and Stepaniuc and there is one vacant seat. Four new substitutes have been appointed to replace MM. Ivanov, Palamarciuc, Mrs Patereu and Mr Popa.
3. *The Netherlands* has appointed one new representative to replace Mr Visser who has resigned.
4. *"The former Yugoslav Republic of Macedonia"* has appointed one new representative to replace Mrs Petrova-Mitevaska who has resigned.
5. Following parliamentary elections, *the United Kingdom* has appointed nine new representatives to replace MM. Atkinson, Bruce, Sir Chapman, Mr Cox, Lord Judd, Mr McNamara, Sir Taylor, MM. Wilkinson and Wray, who are no longer members of the delegation. Fifteen new substitutes have been appointed to replace Lord Burlinson, Mr Hancock, Baroness Hooper, MM. Malins, Meale, Lord Tomlinson, MM. Walter and Wilshire, who have been appointed representative, and Mr Banks, Baroness Billingham, Mrs Cryer, Mr Foulkes, Ms Griffiths, Lord Kilclooney and Mr Rapson, who are no longer members of the delegation.
6. The Standing Committee, acting on behalf of the Assembly, is called upon to express its decision on the validation of the credentials of the members whose names are given below.
7. In the case of objection or justified contestation, the contested credentials shall be referred without debate to the appropriate committee which shall report back to the Assembly, in accordance with Rules 7 and 8 of the Rules of Procedure.
