Introduction

The legally binding Kyoto Protocol of December 1997 obliges the EU to reduce CO2-emissions by 8 % up to 2012. But the transport sector is a serious obstacle for achieving this goal, as its growth of fossil energy consumption and negative impact on climate change could not be broken during the last decades, mainly due to the increasing volumes of road and air transport.

This workshop aims to find better answers on how to reduce CO2-emissions within the transport sector and which scenarios or strategies offer a perspective to a trend-break in transport policy towards a drastic reduction of climate change. The focus will be put on air transport, long distance freight and urban persons mobility, as these are our main fields of concern.
