- Creation of employment (RES and EE measures create jobs in particular at regional level,

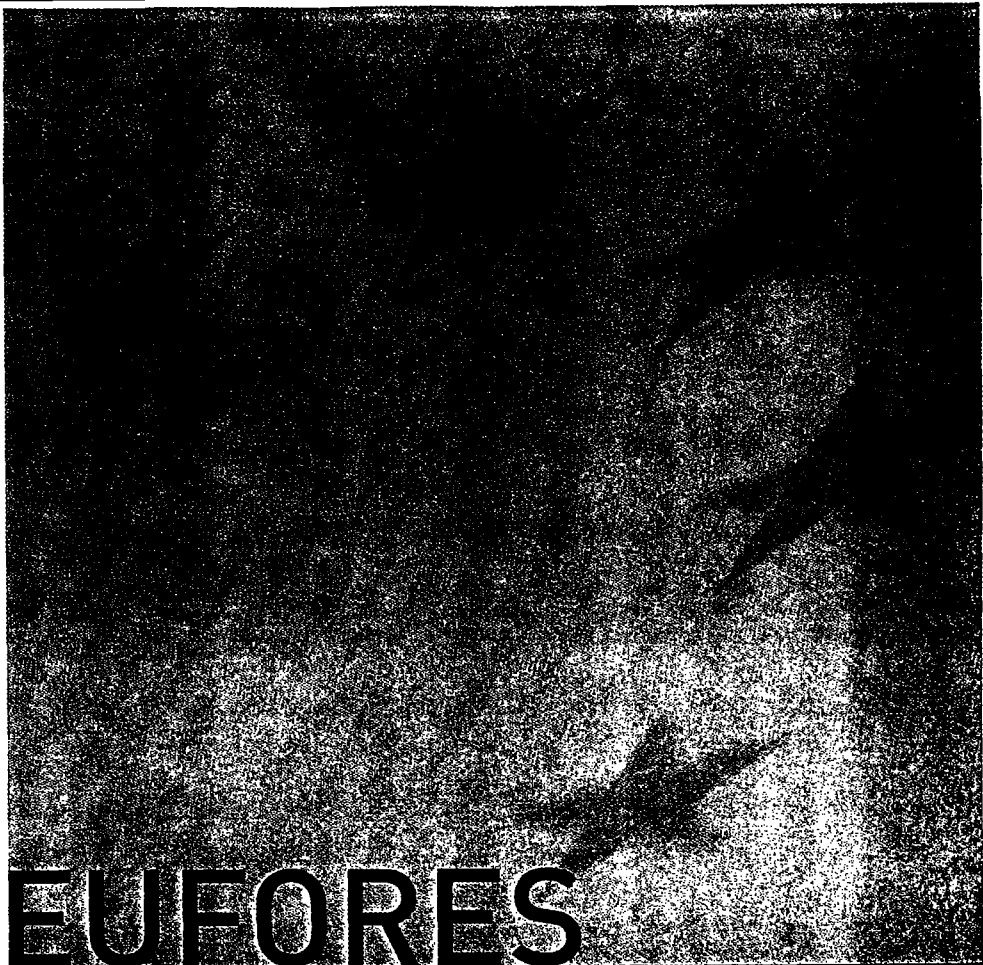
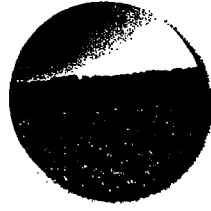
