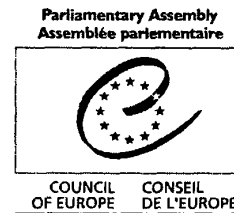

MINUTES OF PROCEEDINGS

Mr René van der Linden, President of the Assembly, took the Chair at 10.05 a.m.

1. ATTENDANCE REGISTER

The names of the Representatives, Substitutes and Observers who signed the attendance register are given in the Appendix.

2. MINUTES

The minutes of the second sitting were agreed to.

3. ORGANISATION OF DEBATES

On the proposal of the President, the Assembly agreed that the list of speakers on human rights violations in the Chechen Republic would be interrupted at 11.15 a.m.

4. HUMAN RIGHTS VIOLATIONS IN THE CHECHEN REPUBLIC: THE COMMITTEE OF MINISTERS' RESPONSIBILITY VIS-À-VIS THE ASSEMBLY'S CONCERNS

The Report of the Committee on Legal Affairs and Human Rights on Human Rights Violations in the Chechen Republic (Doc. 10774) was presented by Mr Erik Jurgens, on behalf of Mr Rudolf Bindig, Rapporteur.

The debate was opened.

Speakers: Mr Christos Pourgourides, Mrs Elene Tevdoradze, Mr Christopher Chope, Mr Doros Christodoulides, Mr Andreas Gross.

Mr Jean-Charles Gardetto, a Vice-President of the Assembly, took the chair in place of Mr René van der Linden.

Speakers: Mr Leonid Slutsky, Mr Ivan Ivanov, Mr Egidijus Vareikis, Mr Konstantin Kosachev, Mrs Marie-José Laloy, Mr Marko Mihkelson, Mr Andres Herkel, Mr Akhmar Zavgayev, Ms Kateřina Konečná, Mr Vladimir Zhirinovskiy, Mr Valery Grebennikov.

The list of speakers was interrupted.

The text of the remaining speeches could be printed with the Official Report.

Mr Erik Jurgens and Mr Dick Marty, Chairperson of the Legal Affairs and Human Rights Committee, replied to the debate.

The debate was closed.

The Assembly considered the draft Resolution contained in Doc. 10774.

The President announced that the amendments to the draft Resolution would be taken in the following order: Nos 1, 2, 8, 9, 10, 3, 4, 11, sub-amendment 1, 5, 12, sub-amendment 2, 6, 13, 14, sub-amendment 3.

An amendment (No. 1) was proposed by Mr Valery Grebennikov, Mr Anatoliy Korobeynikov, Mr Vladimir Mokry, Mr Victor Kolesnikov, Mr Valery Fedorov, Mr Yuri Sharandin, Mr Leonid Slutsky, Mr Tigran Torosyan, Mr Petr Lachnit, Mrs Hermine Naghdalyan, in the draft resolution, paragraph 2, to delete the words "in a climate of impunity".

Speakers: Mr Valery Grebennikov, Mr Erik Jurgens, Mr Dick Marty.

The amendment was not agreed to.

Another amendment (No. 2) was proposed by Mr Leonid Slutsky, Mr Valery Grebennikov, Mr Anatoliy Korobeynikov, Mr Vladimir Mokry, Mr Victor Kolesnikov, Mr Valery Fedorov, Mr Yuri Sharandin, Mr Tigran Torosyan, Mr Petr Lachnit, Mrs Hermine Naghdalyan, in the draft resolution, paragraph 4, replace the words "the lack of substantial" with the following word: "insufficient".

The amendment was agreed to.

The amendment was agreed to.

Another amendment (No. 10) was proposed by Mr Christos Pourgourides, Mrs Lydie Err, Mr Boriss Cilevičs, Mr Walter Riester, Mrs Herta Däubler-Gmelin, Mrs Tana de Zulueta, in the draft resolution, at the end of paragraph 5, add the following sentence "Moreover, the authorities should authorize the publication of the reports of all CPT visits and publish plans and steps taken to implement CPT recommendations."

The amendment was not agreed to.

Another amendment (No. 4) was proposed by Mr Valery Grebennikov, Mr Anatoliy Korobeynikov, Mr Vladimir Mokry, Mr Victor Kolesnikov, Mr Valery Fedorov, Mr Yuri Sharandin, Mr Leonid Slutsky, Mr Tigran Torosyan, Mr Petr Lachnit, Mrs Hermine Naghdalyan, in the draft resolution, to delete paragraph 7.

Speakers: Mr Valery Grebennikov, Mr Erik Jurgens, Mr Dick Marty.

The amendment was not agreed to.

An oral amendment was proposed by Mr Erik Jurgens, in the draft resolution, in paragraph 7, after "The Assembly", to insert "welcomes the recent adoption of a law making it possible to set up inquiry committees and".

The President declared that the oral amendment met the criteria of Rule 34.6.

The oral amendment was agreed to.

Another amendment (No. 11) was proposed by Mr Christos Pourgourides, Mrs Lydie Err, Mr Walter Riester, Mrs Herta Däubler-Gmelin, Mrs Tana de Zulueta, in the draft resolution, at the end of paragraph 7, add the following sentence: "Moreover, the Russian authorities must take practical steps to address the issue of missing persons and "disappeared" persons, particularly through introducing effective systems for identification and recording of bodies found and to make this information public."

Speaker: Mr Christos Pourgourides.

A sub-amendment was proposed by Mr Erik Jurgens, on behalf of the Committee on Legal Affairs and Human Rights, in amendment 11, replace the words "at the end of paragraph 7, add the following sentence" with the following words: "after paragraph 7, add the following new paragraph".

The sub-amendment was agreed to.

The amendment was agreed to.

Another amendment (No.12) was proposed by Mr Christos Pourgourides, Mrs Lydie Err, Mr Walter Riester, Mrs Herta Däubler-Gmelin, Mrs Tana de Zulueta, in the draft resolution, paragraph 11, replace the second and third sentences with the following sentences:

"The Assembly expresses concern that the recently adopted law on the legal status of civil society organisations falls short of the standards of the Council of Europe. The Assembly is also concerned about reports on administrative and judicial harassment of some non-governmental organisations, including in particular the Russian-Chechen Friendship Society."

A sub-amendment was proposed by Mr Erik Jurgens, on behalf of the Committee on Legal Affairs and Human Rights, in amendment 12, delete the words "including in particular the Russian-Chechen Friendship society".

The sub-amendment was agreed to.

The amendment, as amended, was agreed to.

The President announced that as a result of amendment No. 12 being agreed to, tabled amendment No. 6 would fall.

Another amendment (No. 13) was proposed by Mr Christos Pourgourides, Mrs Lydie Err, Mr Walter Riester, Mrs Herta Däubler-Gmelin, Mrs Tana de Zulueta, in the draft resolution, at the end of paragraph 11, add the following words: "and - in line with resolution 1455 - reiterates its call on the Russian government to give NGOs the possibility to do their important work by creating administrative, fiscal and political conditions for the normal functioning of Russian civil society".

The amendment was agreed to.

Another amendment (No. 14) was proposed by Mr Christos Pourgourides, Mrs Lydie Err, Mr Boriss Cilevičs, Mr Walter Riester, Mrs Herta Däubler-Gmelin, Mrs Tana de Zulueta, in the draft resolution, after paragraph 11, to insert the following paragraph:

"The Assembly urges the Russian government to fully implement all recommendations made by the bodies and mechanisms of the Council of Europe including the Parliamentary Assembly, the Commissioner for Human Rights, the Committee for the Prevention of Torture (CPT), the Venice Commission and the European Commission against Racism and Intolerance (ECRI) as well as those of the UN, including the Human Rights Committee, the Committee Against Torture, the Committee on the Elimination of Discrimination Against Women, the Committee on the Rights of the Child and the Representative of the Secretary General on Internally Displaced Persons."

A sub-amendment was proposed by Mr Erik Jurgens, on behalf of the Committee on Legal Affairs and Human Rights, in amendment 14, delete the words: "including the Parliamentary Assembly, the Commissioner for Human Rights, the Committee for the Prevention of Torture (CPT), the Venice Commission and the European Commission against Racism and Intolerance (ECRI)" and the words: "including the Human Rights Committee, the Committee against Torture, the Committee on the Elimination of Discrimination against Women, the Committee on the Rights of the Child and the Representative of the Secretary General on Internally Displaced Persons".

The sub-amendment was agreed to.

The Assembly agreed the draft Resolution contained in Doc. 10774, as amended (*Resolution 1479 (2006)*).

The Assembly considered the draft Recommendation contained in Doc. 10774.

The President announced that the amendments to the draft Recommendation would be considered in the following order: 7 with sub-amendment, 15, 16, 17, 18 with sub-amendment.

An amendment (No. 7) was proposed by Mr Valery Grebennikov, Mr Anatoliy Korobeynikov, Mr Vladimir Mokry, Mr Victor Kolesnikov, Mr Valery Fedorov, Mr Yuri Sharandin, Mr Leonid Slutsky, Mr Tigran Torosyan, Mr Petr Lachnit, Mrs Hermine Naghdalyan, in the draft recommendation, paragraph 2, replace the words "the Council's executive body" with the following words: "this Council's body".

Speaker: Mr Valery Grebennikov.

A sub-amendment was proposed by Mr Erik Jurgens, on behalf of the Committee on Legal Affairs and Human Rights, in amendment 7, replace the words "this Council's body" with the following words: "the Council's decision-making body".

The sub-amendment was agreed to.

The amendment, as amended, was agreed to.

Another amendment (No. 15) was proposed by Mr Christos Pourgourides, Mrs Lydie Err, Mr Boriss Cilevičs, Mr Walter Riester, Mrs Herta Däubler-Gmelin, Mrs Tana de Zulueta, in the draft recommendation, at the end of paragraph 5.1, add the following words: "and making monitoring reports and findings public".

Speakers: Mr Christos Pourgourides, Mr Erik Jurgens, Mr Dick Marty.

The amendment was not agreed to.

Another amendment (No. 16) was proposed by Mr Christos Pourgourides, Mrs Lydie Err, Mr Boriss Cilevičs, Mr Walter Riester, Mrs Herta Däubler-Gmelin, Mrs Tana de Zulueta, in the draft recommendation, at the end of paragraph 5.3, add the following words: ", and to urge the Russian authorities to authorize, without delay, the publication of all reports of visits to the region by the Council of Europe's Committee for the Prevention of Torture (CPT)".

The amendment was agreed to.

Another amendment (No. 17) was proposed by Mr Christos Pourgourides, Mrs Lydie Err, Mr Walter Riester, Mrs Herta Däubler-Gmelin, Mrs Tana de Zulueta, in the draft recommendation, after paragraph 5.3, insert the following sub-paragraph: "calls on the Committee of Ministers to ensure that the Council of Europe supports the authorities in the Russian Federation in taking practical steps to address the issue of missing persons and 'disappeared' persons in Chechnya, particularly through introducing effective systems for identification and recording of bodies found, and improvement of the forensic facilities in Chechnya."

The amendment was agreed to.

Another amendment (No. 18) was proposed by Mr Christos Pourgourides, Mrs Lydie Err, Mr Walter Riester, Mrs Herta Däubler-Gmelin, Mrs Tana de Zulueta, in the draft recommendation, after paragraph 5.3, insert the following sub-paragraph: "continue to bring appropriate pressure to bear upon the Russian authorities to implement the individual and general measures in relation to all European Court of Human Rights judgments, in particular those relating to violations committed in the course of the armed conflict in Chechnya."

A sub-amendment was proposed by Mr Erik Jurgens, on behalf of the Committee on Legal Affairs and Human Rights, in amendment 18, replace the words "to bring appropriate pressure to bear upon the Russian authorities" with the following words: "to urge the Russian authorities".

The sub-amendment was agreed to.

The amendment, as amended, was agreed to.

The Assembly agreed to the draft Recommendation contained in Doc. 10774, as amended (*Recommendation 1733 (2006)*).
