# **BEYOND THE 2005 YEAR OF DEVELOPMENT: WHAT NOW?**

## DRAFT PROGRAM -- SUBJECT TO CHANGE

The annual conferences of the Parliamentary Network on the World Bank, now in its sixth edition, bring together some 200 parliamentarians from around the world with representatives from the World Bank and other multilateral organizations, academia, civil society and the private sector. The objectives are to identify what parliamentarians can do to promote action on pressing development issues, and to help strengthen the accountability and transparency of international financial institutions.

This "Year of Development" has presented an unprecedented opportunity to build political support behind efforts to reach the Millennium Development Goals. In Helsinki, participants at the Sixth Annual PNoWB conference will review the outcomes of July's G8 "development summit" in Gleneagles, Scotland and September's United Nations World Summit in New York as well as preview December's important WTO ministerial meeting in Hong Kong on the Doha Development Agenda. The discussions will center around the theme: *Beyond the 2005 Year of Development: What Now?* This year's conference will also present the recently-appointed World Bank President Paul Wolfowitz his first occasion to meet PNoWB members.

The annual conference doubles as PNoWB's general assembly. The Helsinki conference will review the Network's progress report on its activities since its last annual meeting in February 2004 as well as elect a new board.

Hosted by the Parliament of Finland, the conference is organized by the Parliamentary Network on the World Bank, in collaboration with the World Bank, the Parliament and Finland's Ministry of Foreign Affairs.

# ... Clinching A Pro-Poor Deal on Trade in Agricultural Products (and Handling New Textile Quota Regime)

<u>Description</u>: Agriculture remains the economic driving force in many developing countries, and agricultural growth is often the cornerstone for poverty reduction. In low-income countries, some 70 percent of the population depends on agriculture for their livelihoods. But high tariffs, \$300-billion-ayear domestic farming subsidies in rich countries, and complicated health and safety regulations make it difficult for poor countries to trade in farming products. This session will review the current status of the WTO negotiations on agricultural trade and explore what parliamentarians can do inch the Doha Development Agenda towards a pro-development conclusion. Separately, the session will look at the role of parliamentarians in addressing the fall-out of the end of the textile quotas phase-out.

## Session A

... Ensuring Accountability: How to strengthen the parliamentary voice on development and global issues

<u>Description</u>: Parliaments, designed in part to provide a check on power and a link between rulers and citizens, are struggling to meet fresh demands borne by globalization. Decisions made in international fora and corporate boardrooms are increasingly affecting local constituents, but the informationsharing infrastructure and the global decision-making structures lag behind. Concerned with the future of democracy and multilateralism, parliamentarians are now responding to the global governance challenge. The session will connect parliamentarians with representatives from key stakeholders and seek concrete suggestions from these groups on how to strengthen the parliamentary voice on development and global issues.

... Addressing Global Inequality: Presentation of the *World Development Report 2006* on Equity and Development

<u>Description</u>: The World Bank's *World Development Report 2006* explores the role of equity in development. Inequalities in incomes, in health and in educational outcomes have long been a stark fact of life in many developing countries. When such inequalities in outcomes arise from unequal opportunities there are both intrinsic and instrumental grounds for concern. Because inequalities in opportunities are often accompanied by profound differences in influence, power and social status, whether at the level of individuals or groups, they have a tendency to persist. The report concludes inequity is inimical to long-run development and needs to be addressed by domestic and international policies and institutions. This session will include a presentation followed by a discussion of the report's findings.

#### Session C

... Realizing Good Intentions in Africa: Implementing NEPAD and the World Bank's new Africa Action Plan

<u>Description</u>: Africa's development challenges have been commanding particular attention during this "Year of Development." The Commission for Africa, which brought together public and private-sector leaders from both donor countries and Africa to design a comprehensive blueprint for addressing the development needs of the continent, delivered its report in March. Meeting at Gleneagles, Scotland in July, G8 leaders agreed to expand debt relief and boost aid for African countries. The World Bank, Africa's single largest donor, has responded with a new African Action Plan. In parallel, the implementation of the objectives set out in the New Economic Partnership for Africa (NEPAD) is moving ahead. The session will explore how parliamentarians from African nations and Africa's partner countries can help translate these strategies into real progress in the fight against poverty.

## Session D

... Reaching a WTO Agreement on Trade in Services: Business Outsourcing, Short-Term Labor Migration, etc...

<u>Description</u>: The services sector—which include activities as different as transport of goods and people, health care, advertising, banking, insurance, accounting, engineering, sanitation, hotels and restaurants, distribution, education and communications—is the largest, fastest growing and most complex part of economic activity in most developed and developing countries. Services account for roughly two-thirds of global output and a significant share of global employment (70 per cent in high-income economies, but less than 30 per cent in most low-income economies). Ongoing WTO negotiations on services have achieved limited progress so far. This session will look at possible consequences of further services liberalization, and at what role parliamentarians can play.
