LAOGAI – The Chinese Gulag

Ladies and Gentlemen,

A couple of months ago we were able to inform you that German Bundestag passed a motion condemning the LAOGAI system in the People's Republic of China.

Bundestag was – after the US Congress in late 2005 – the 2nd national Parliament which does not want to tolerate these camps and the unacceptable Chinese methods any longer. Bundesland Hamburg followed suit despite very close relations with Shanghai.

In order to supply you with more and detailed information on the LAOGAI, Mr. Harry Wu Founder of the LAOGAI Research Foundation Washington DC would like to visit you during the forthcoming winter months. Harry Wu has himself spent 19 years in the LAOGAI – without court hearing and court order. This and his dedicated research make him the world's leading expert on the subject of LAOGAI.

We wonder which months are the most suitable for you to receive Mr. Wu and to talk to him.
