In addition to reports of the companies listed above, data from other sources are included.

Data from five independent providers of broadband connections via internal networks in housing associations and student hostels are included: Bolignet-Aarhus, Dalgas Have (Frederiksberg), Parknet (Copenhagen), Skydebanen (Copenhagen) and Sprotoften (Nyborg).

Furthermore, data from three suppliers of equipment for broadband connections via internal network in housing associations are included: Indienet, Phonenet and Vesterbro ADSL.

The statistics also include data from nine independent community network providers of cable modem services: Faaborg Vest Antenneforening, Fanø Kabelnet, Galnet (Odense), G.V.D. Antenneforening (Aalborg), ka-net (Kalundborg), Klarupnet, NAL-NET (Næsby), Tune Kabelnet and Vejen-Net.

DjurslandS.net has also supplied statistical data.

Finally, the statistics also include data from 94 student hostels.

Demographic indicators as well as data on the net price index (NPI) are provided by Statistics Denmark.

The National IT and Telecom Agency has in certain cases adjusted previously released figures due to new information received from the providers.

In Denmark, telecommunications networks and services may be provided by anyone without a prior licence, registration, or other authorisation. Consequently, the present statistics are subject to the reservation that not all providers of networks and services in the Danish telecommunications market might have been included. Especially in the markets for outgoing international traffic, internet services and cable modems i.e. antenna societies, several providers have emerged in recent years who are not covered by the statistics.

Due to rounding-off, numbers in tables and figures do not always add up to the total shown.

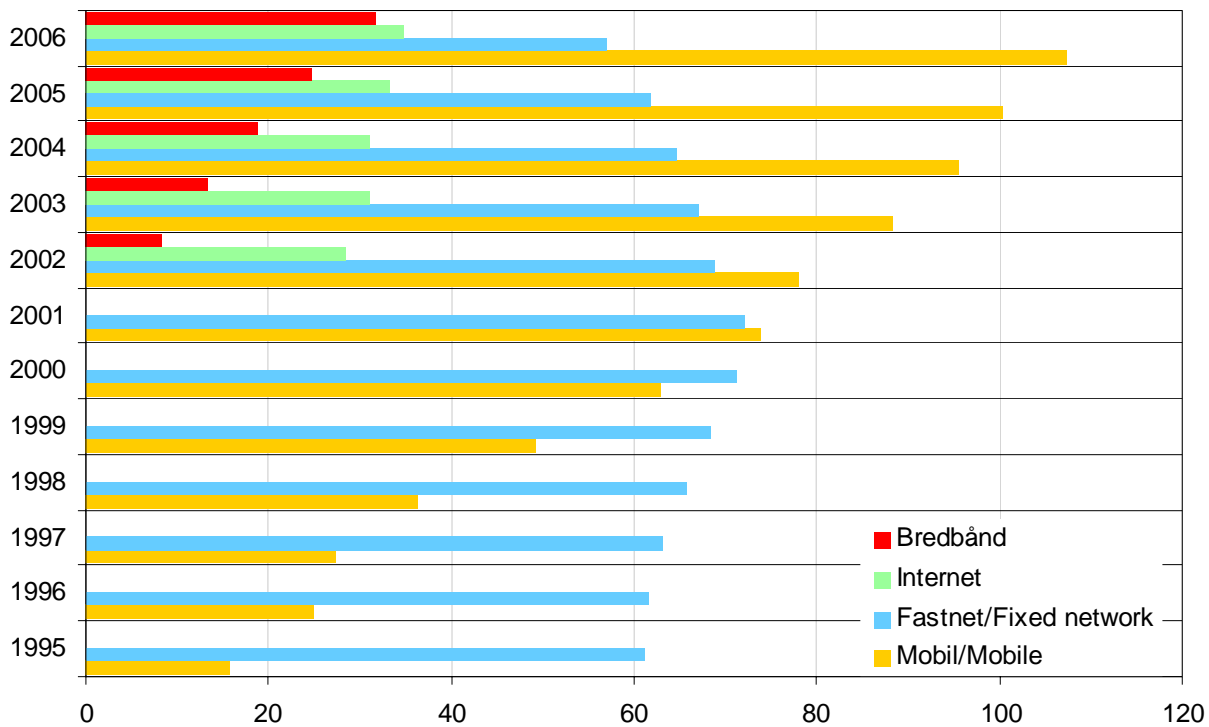

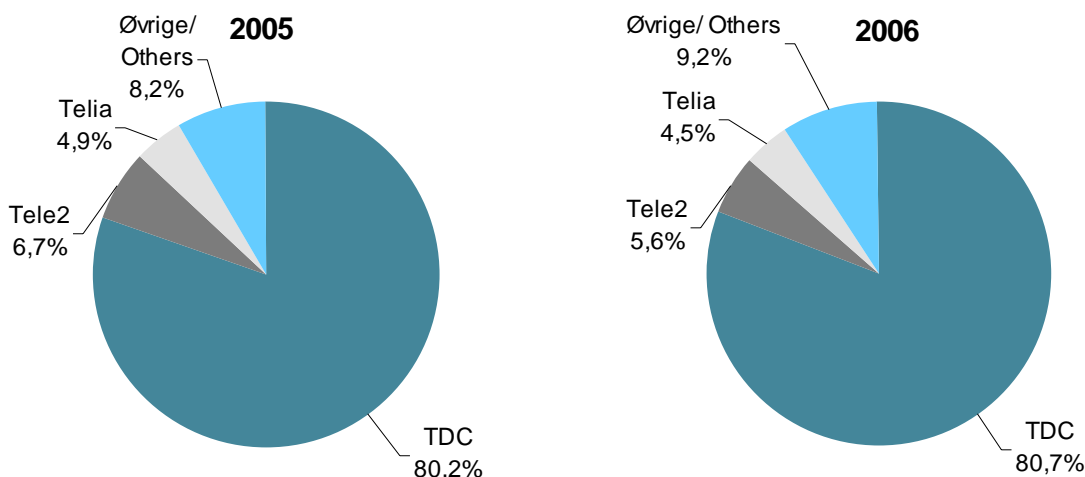

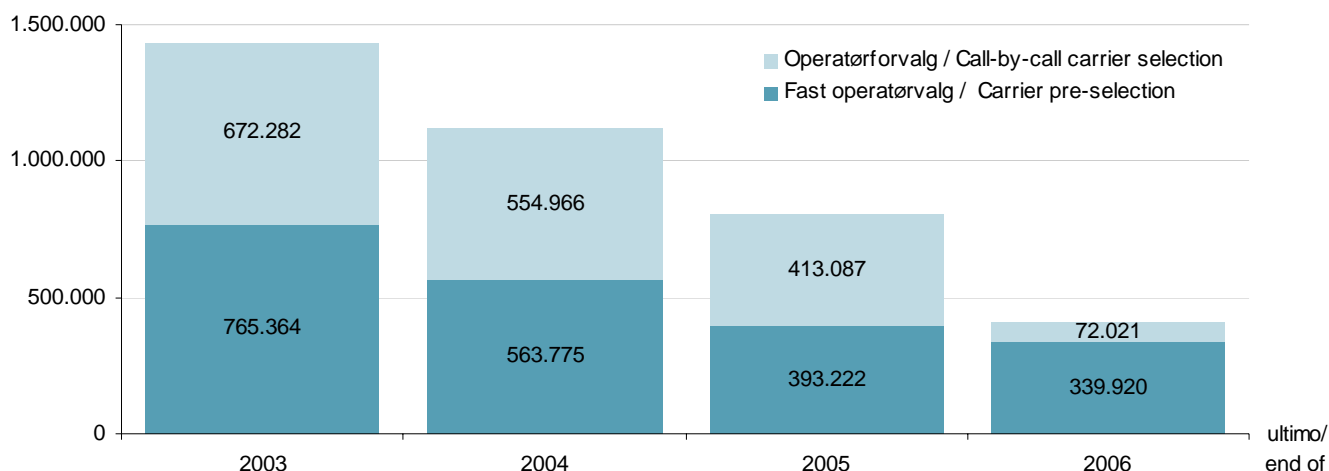

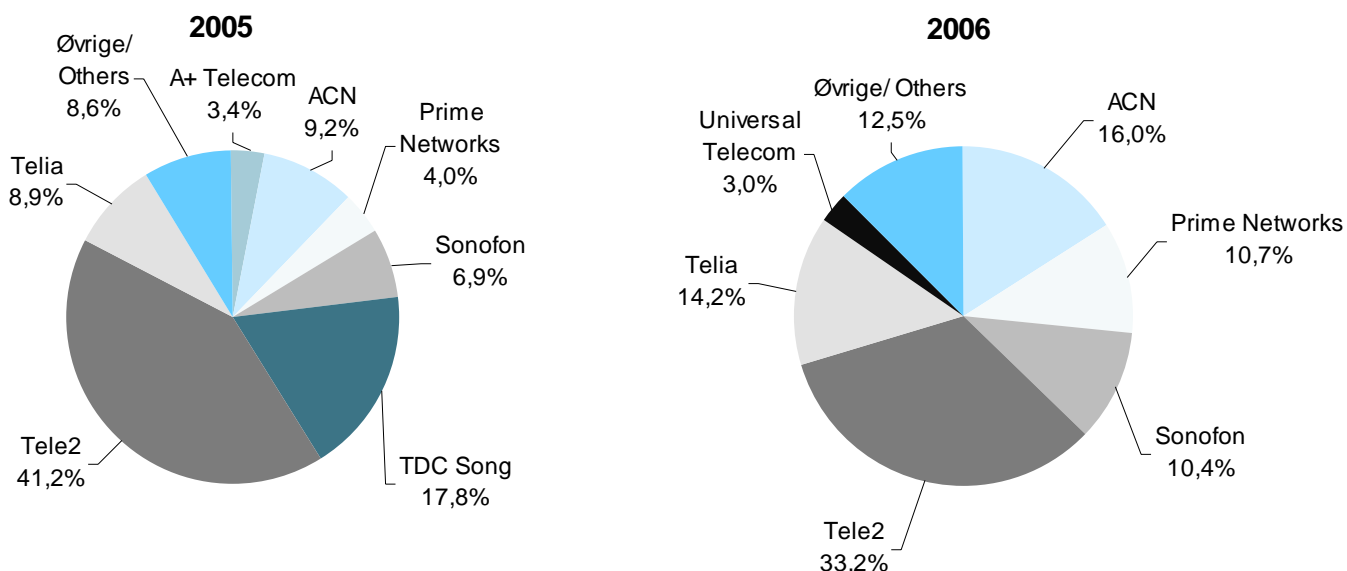

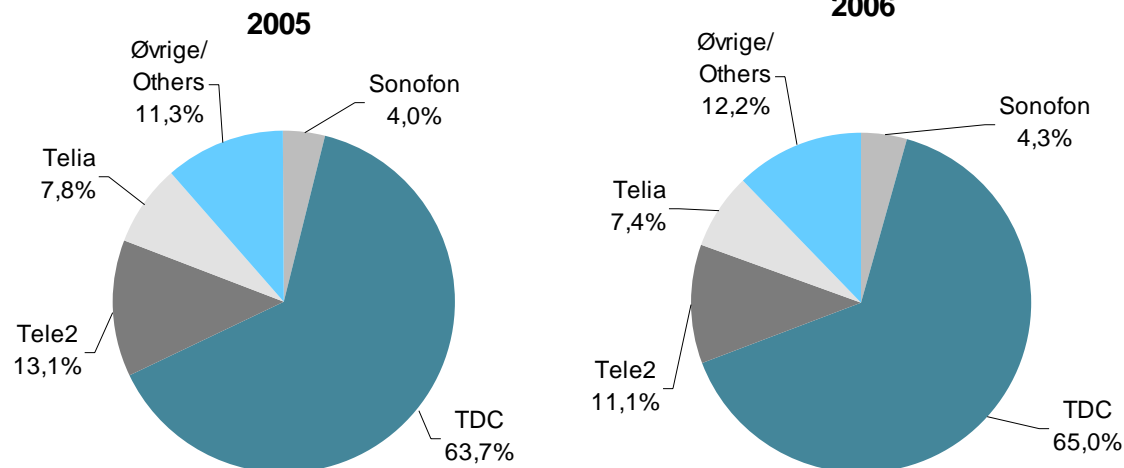

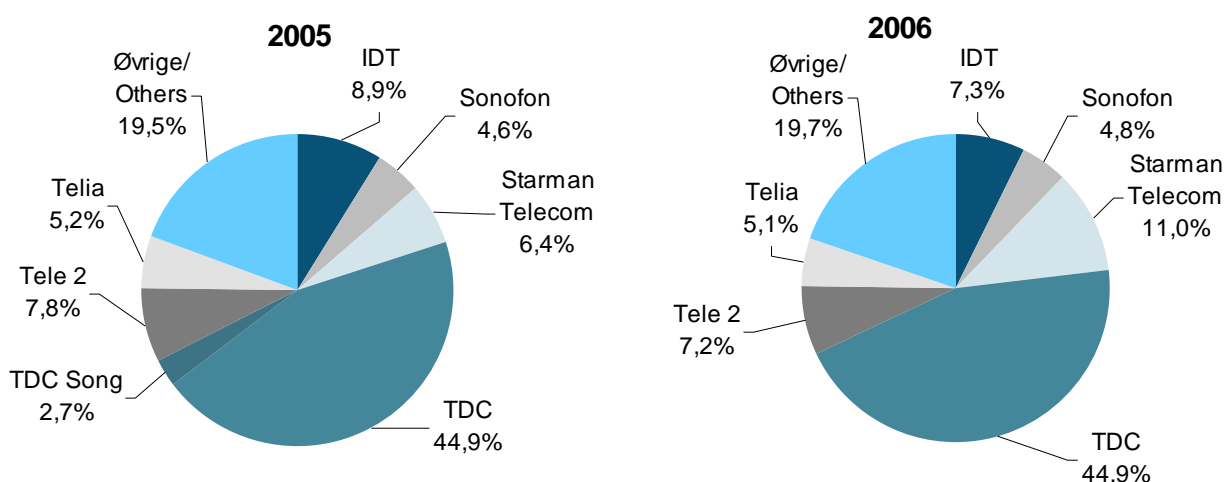

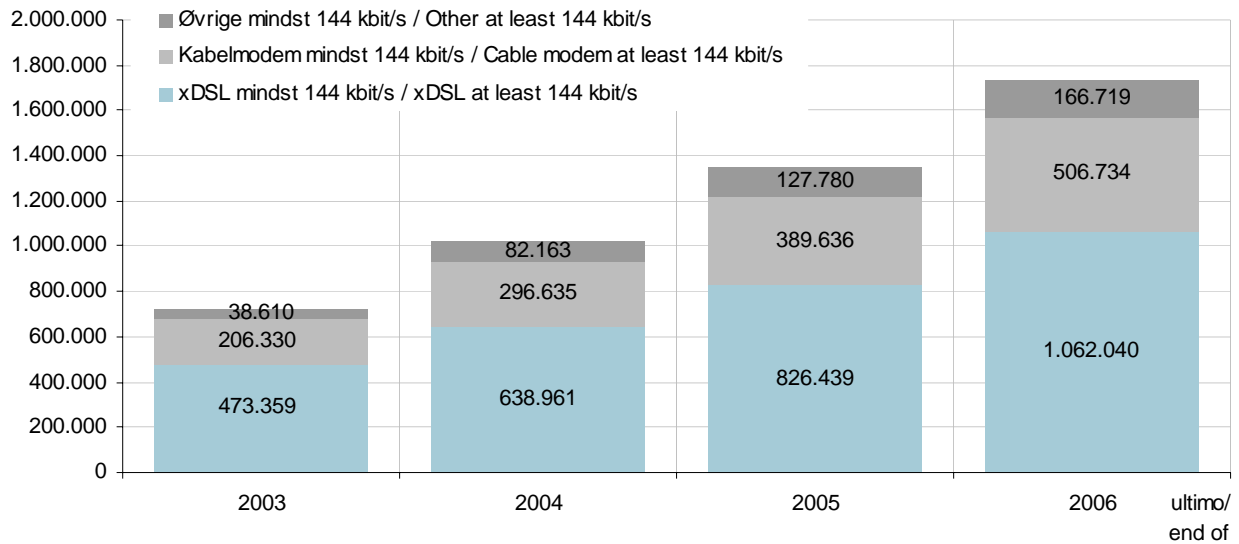

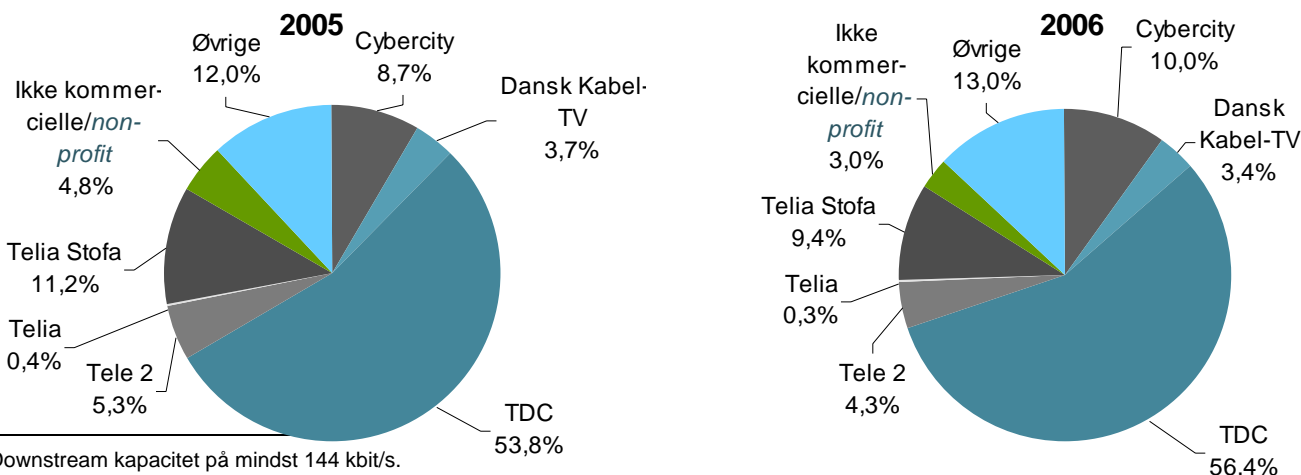

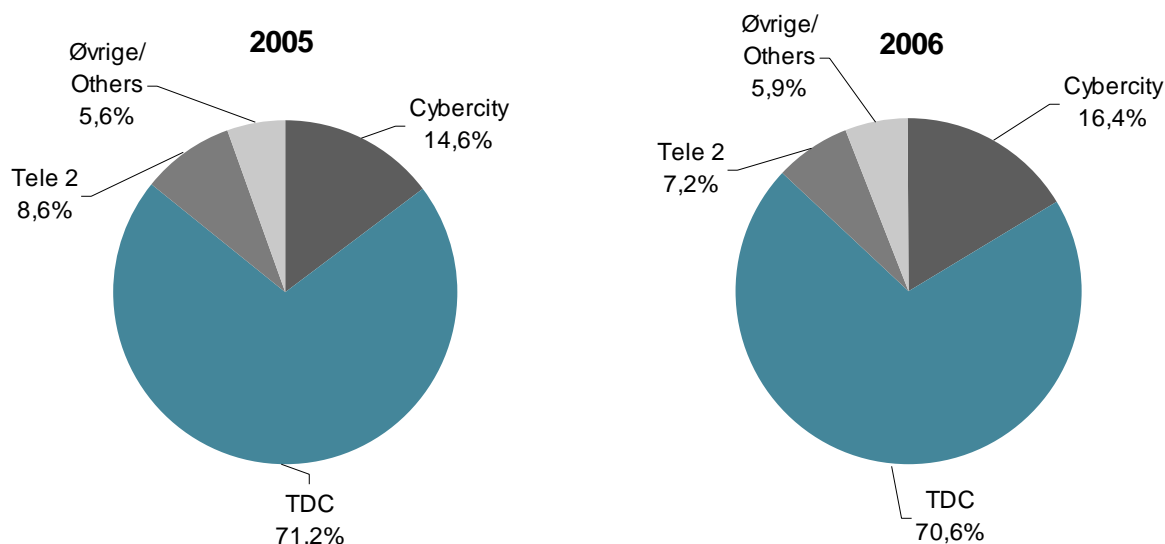

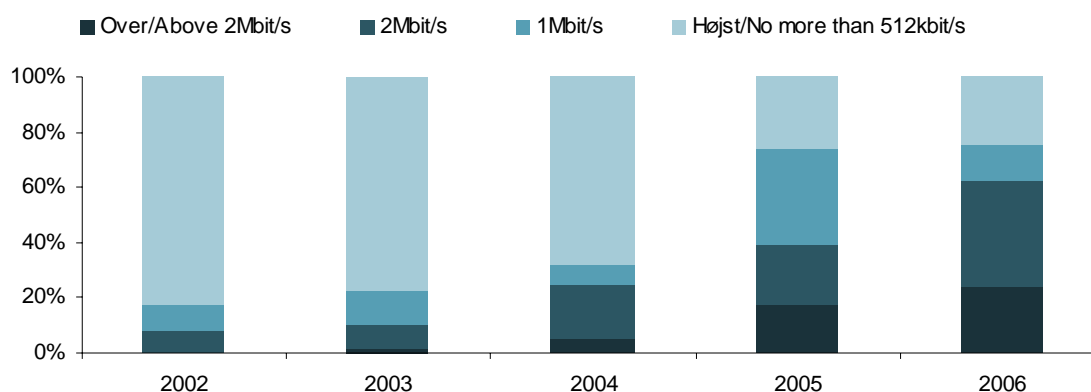

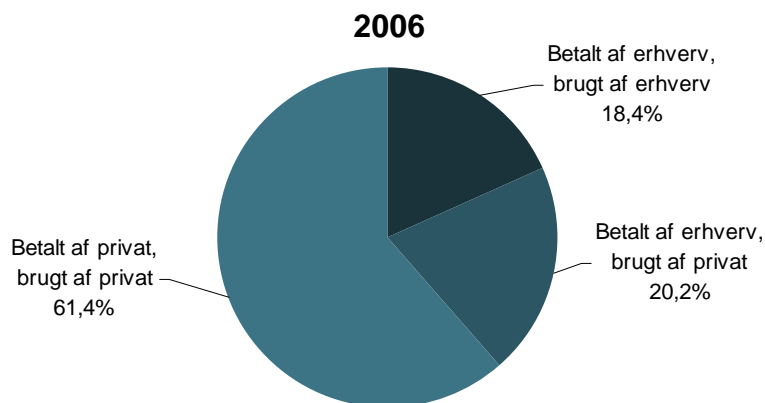

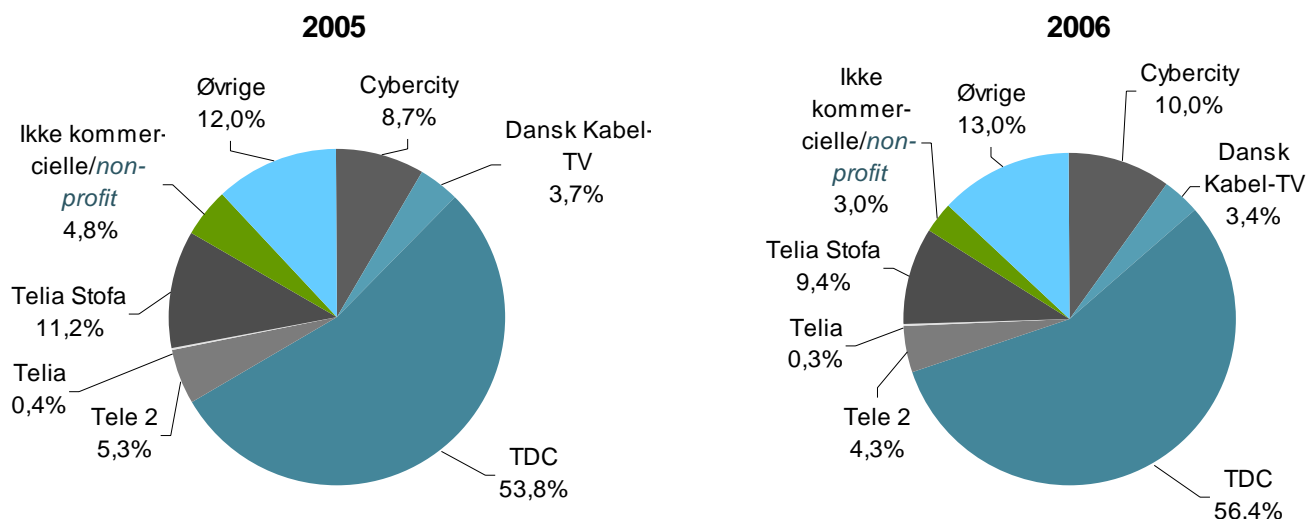

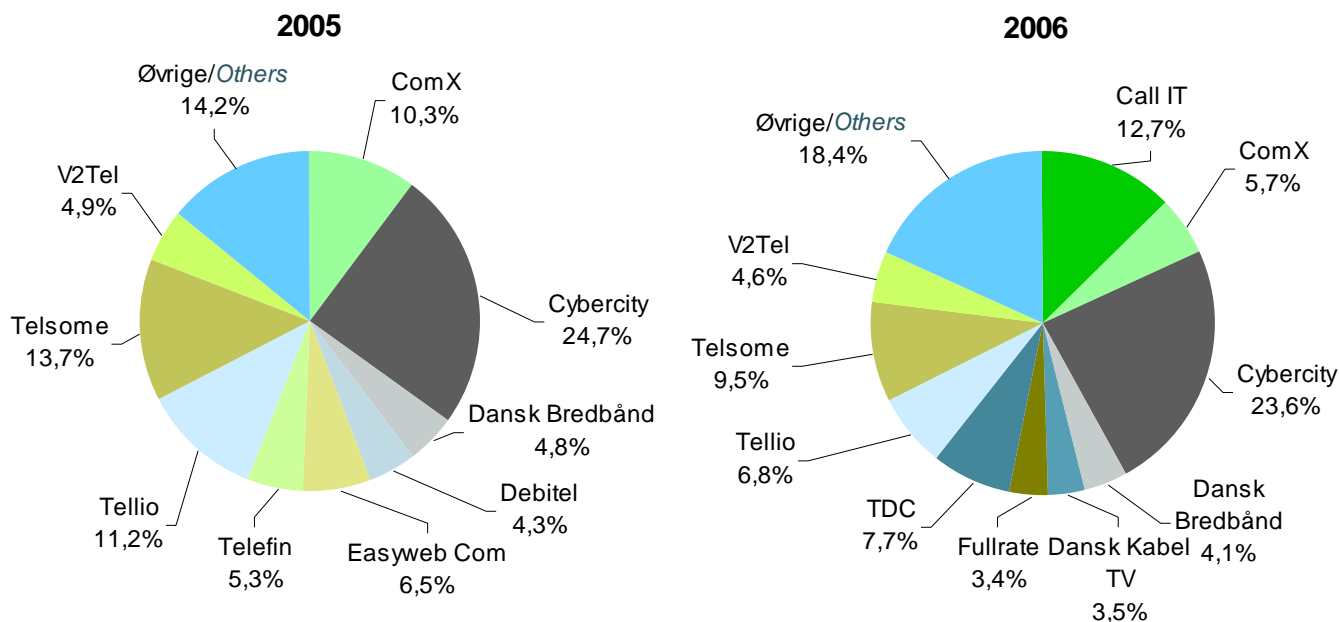

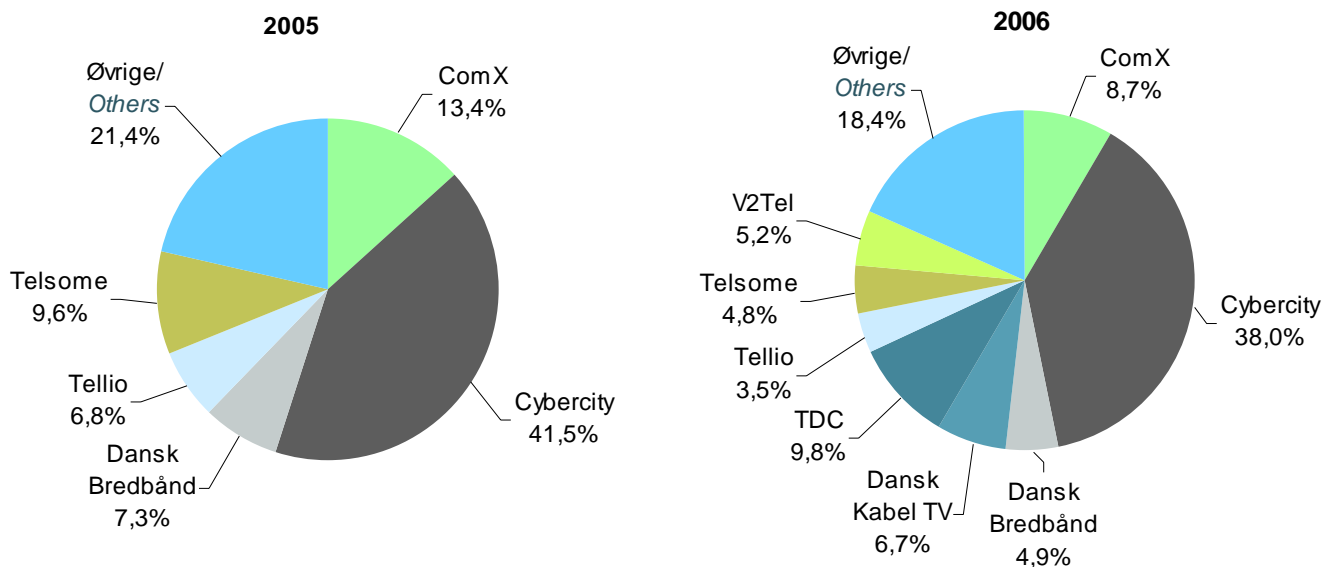

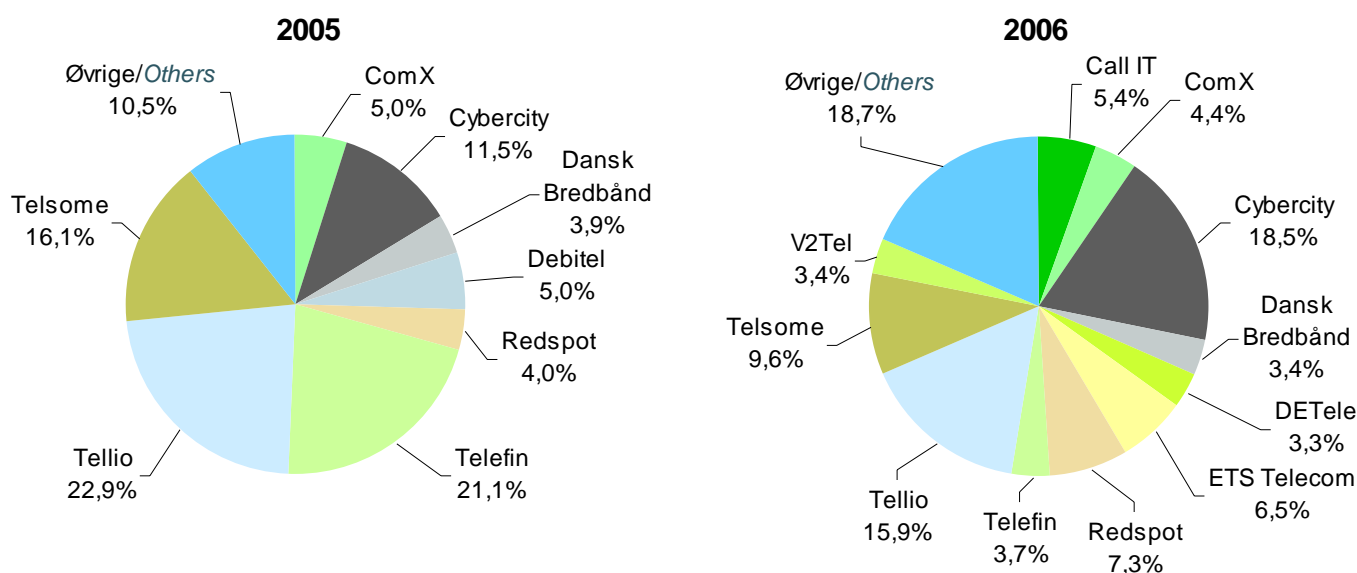

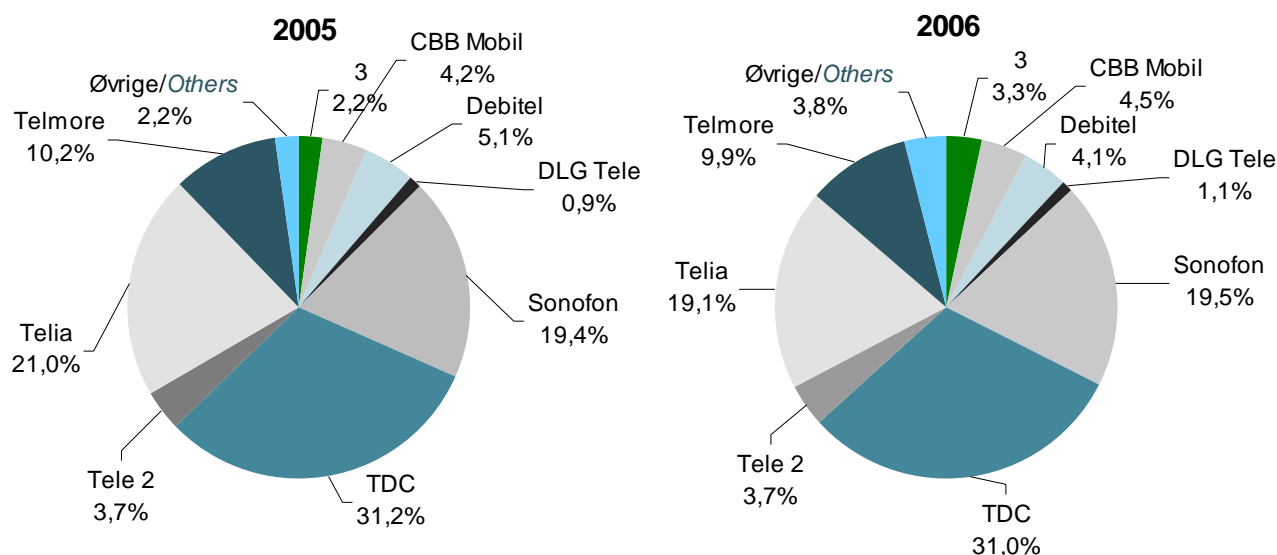

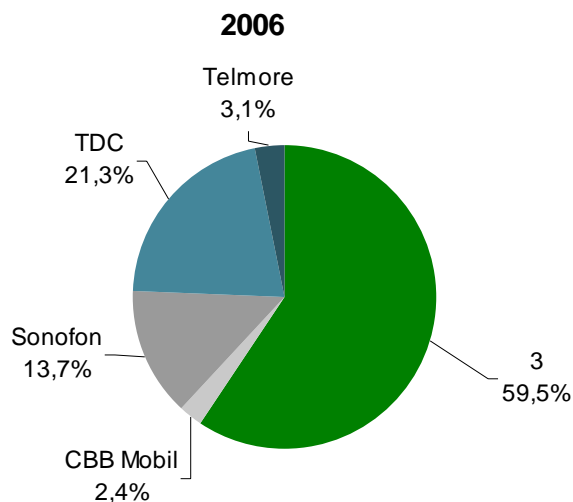

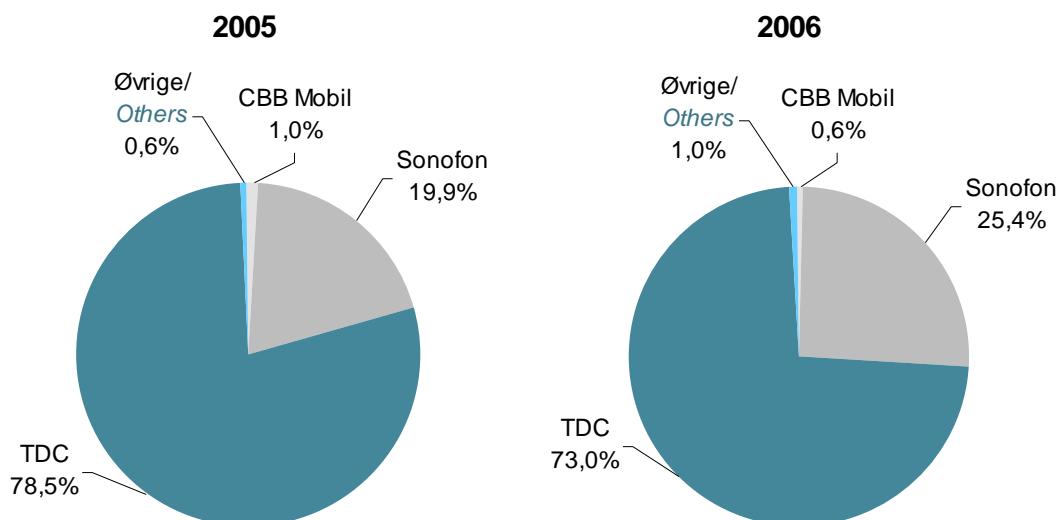

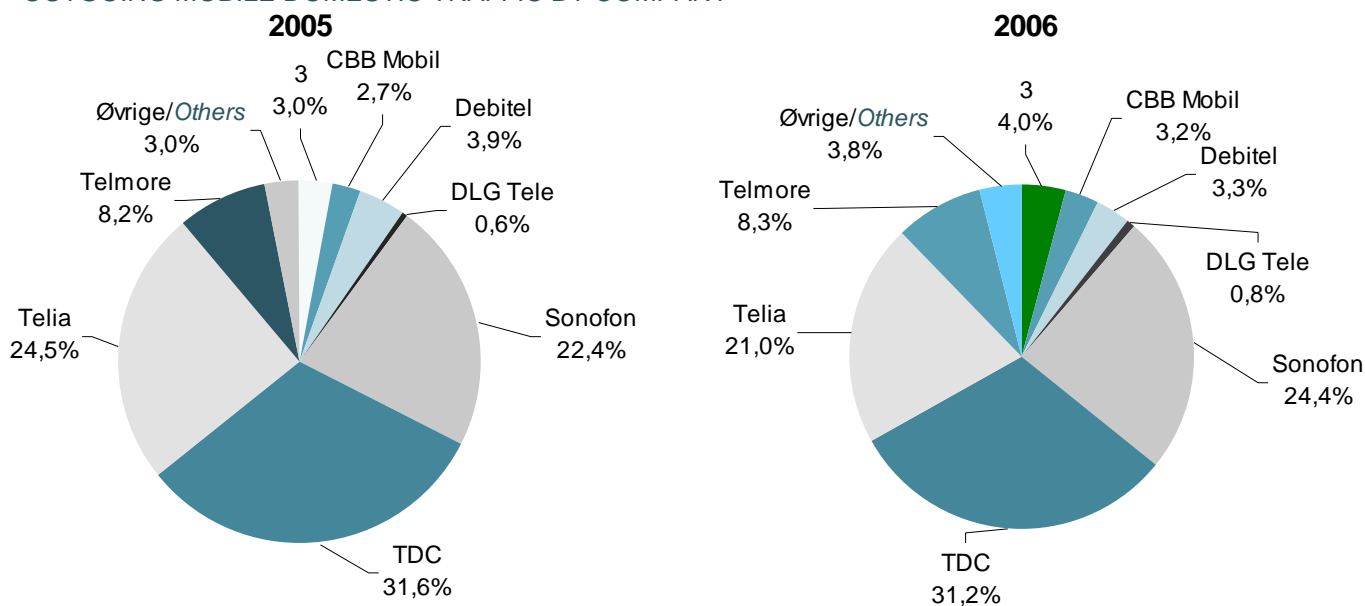

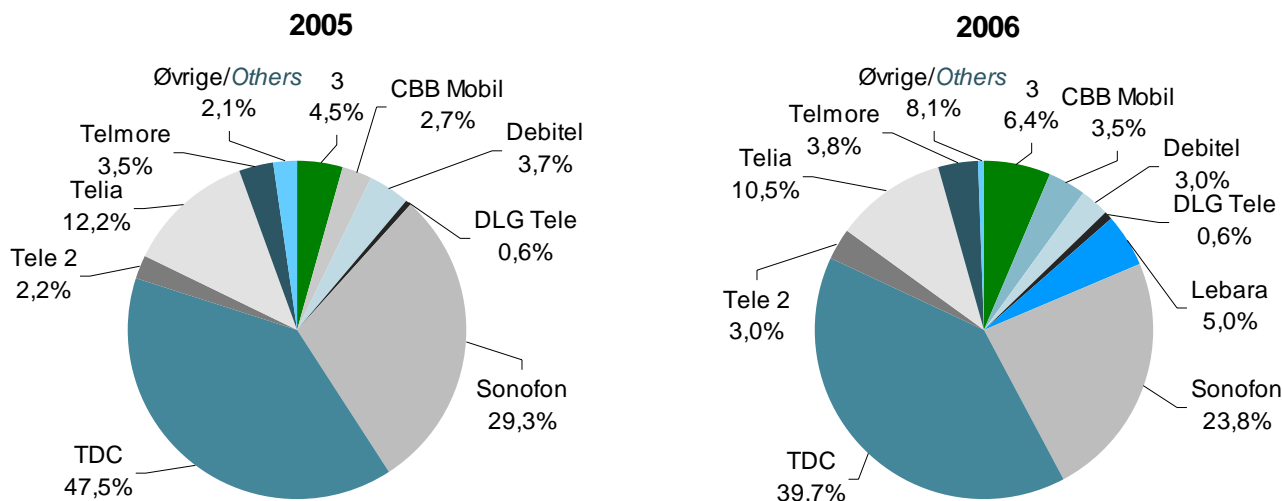

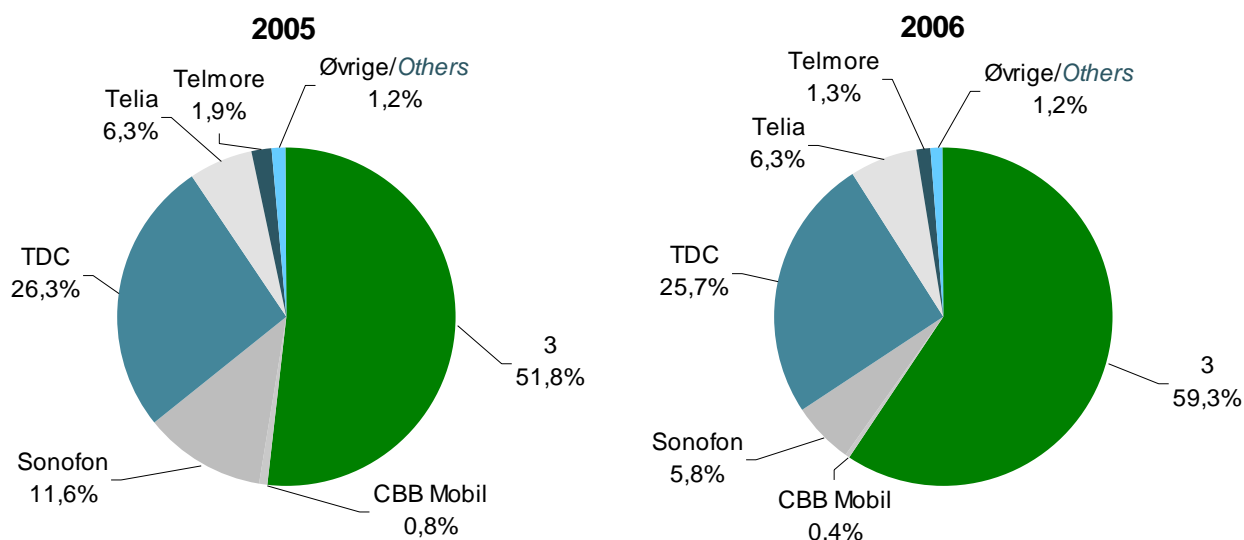

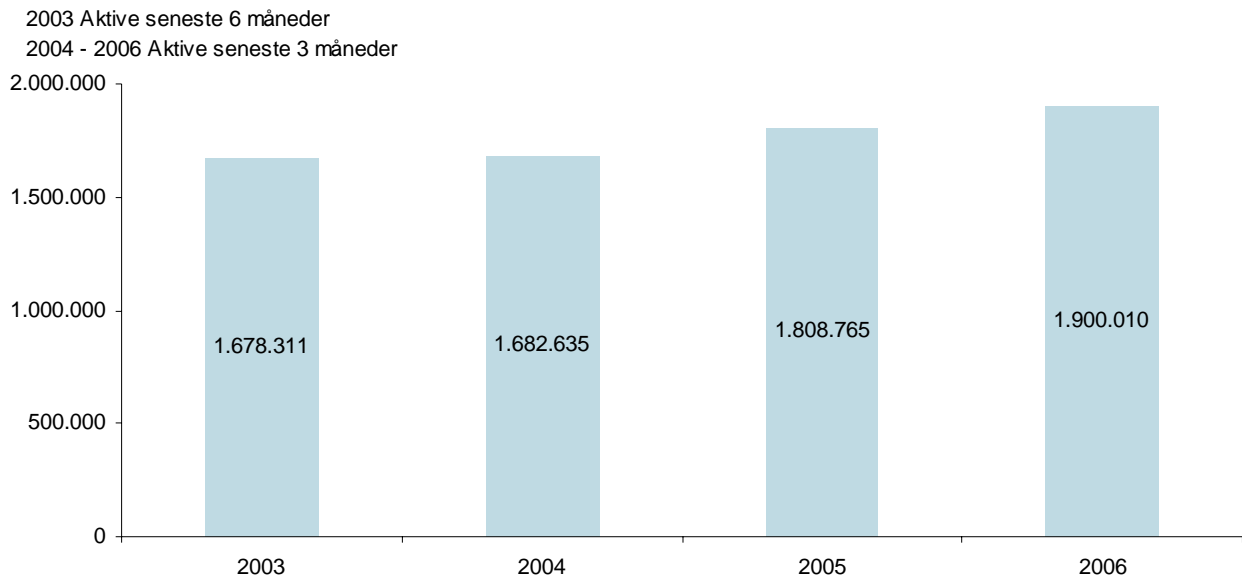

Pjecen er blevet til på baggrund af IT- og Telestyrelsens interaktive teleguide, som indeholder et stort udvalg af teleselskabernes forskellige abonnemeter til fastnet, internet, bredbånd og mobiltelefon. Prispjecen opdateres hvert kvartal og findes i elektronisk udgave på <http://www.itborger.dk/forbrug/Prispjece>.

I nedenstående tabel 43 vises prisudviklingen for det billigste tilbud i udvalgte forbrugsprofiler siden 1998. For at muliggøre en sammenligning over hele perioden, er det de beregningsforudsætninger, der blev benyttet i 1998, der ligger til grund for beregningerne for fastnet- og mobiltelefoni i tabellen. Beregningsforudsætningerne blev opdateret i 2003<sup>1</sup>. Tabel 44 og figur 27 viser prisudviklingen baseret på de nye beregningsforudsætninger.

Bemærk, at priserne for ADSL er for ubegrænset forbrug (flat-rate). Ændringen i beregningsforudsætningerne gælder således ikke for ADSL-priserne, der hverken er baseret på de gamle eller de nye beregningsforudsætninger.

The tables and figures in this chapter illustrate the developments in end-user prices for fixed network and mobile telephony, dial-up internet and broadband (ADSL).

The figures show prices based on the lowest available offer for selected user baskets from the National IT and Telecom Agency's quarterly report on prices, 'Prispjece'. 'Prispjece' is a survey over end-user prices and has been published since August 1998. The survey is based on the National IT and Telecom Agency's interactive teleguide, a database that includes a broad selection of subscriptions for fixed network, internet, broadband and mobile services. The price survey is updated each quarter and can be obtained through the following link (in Danish): <http://www.itborger.dk/forbrug/Prispjece>.

Table 43 reports the price developments of selected end-user products (based on the lowest available offers) since 1998.

In order to be able to compare prices in the period 1998-2007, figures in the table are based on end-user baskets that have been in use since 1998.

The baskets were updated in 2003<sup>1</sup>. Table 44 and figure 27 show the price developments calculated on the basis of the new end-user baskets. Please note, that the prices for ADSL are 'flat-rate' prices, in other words independent of the actual usage. 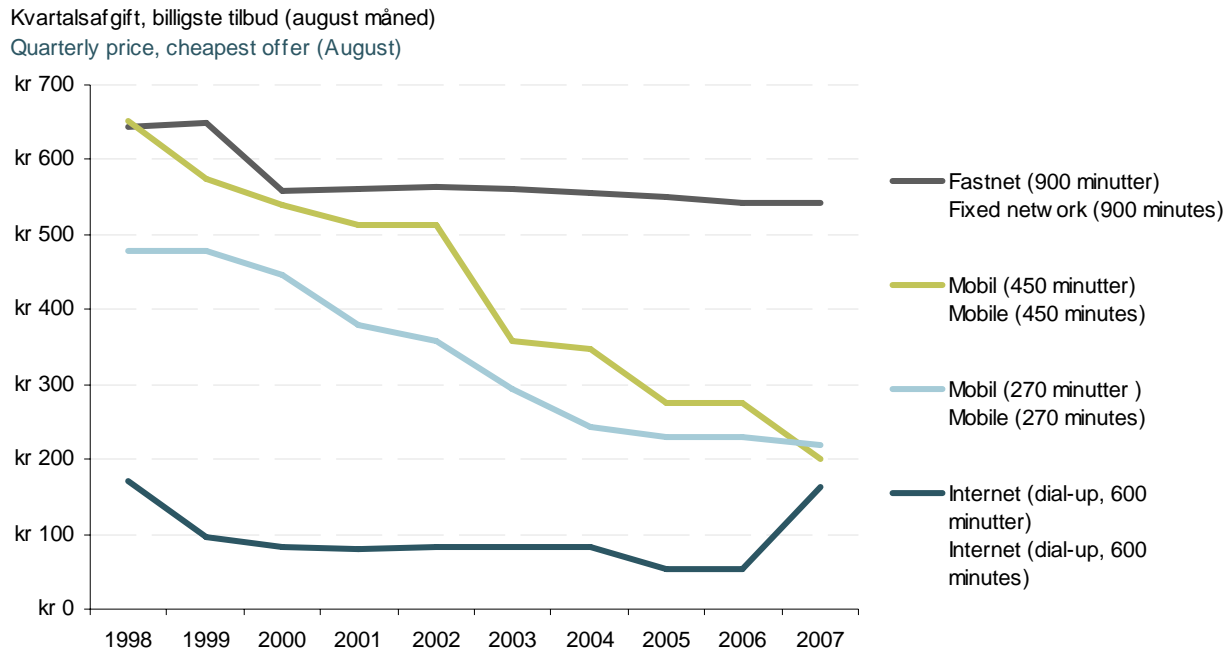

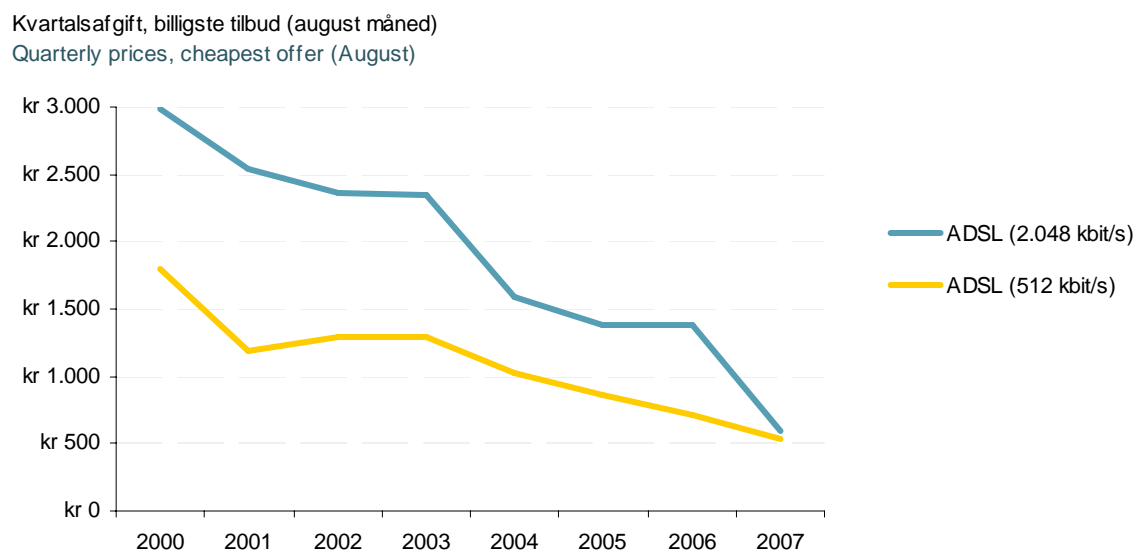

PRICE DEVELOPMENT FOR BROADBAND (ADSL)



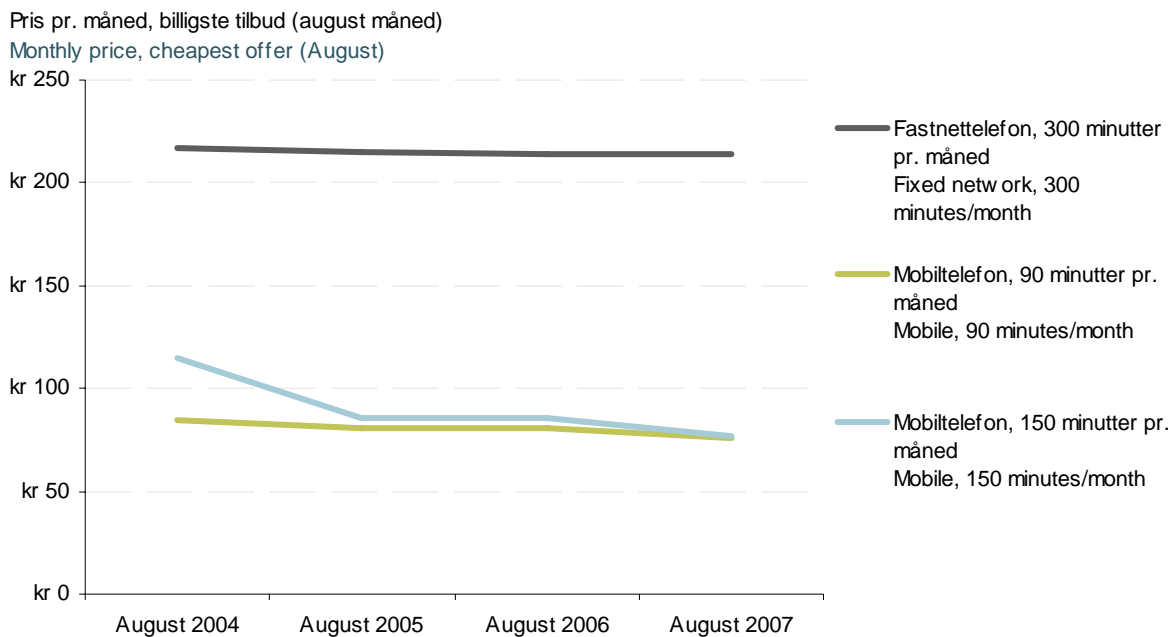

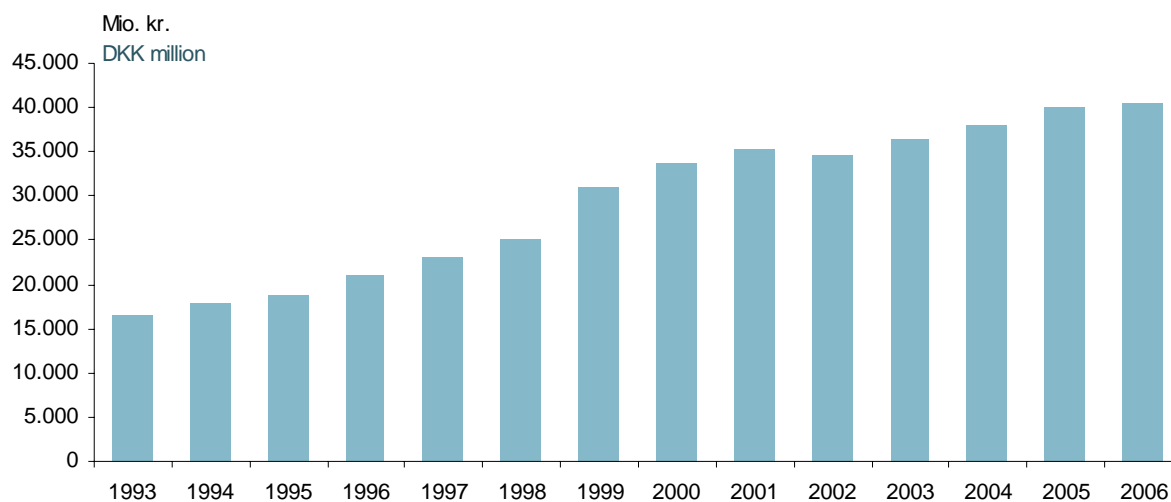

REVENUE



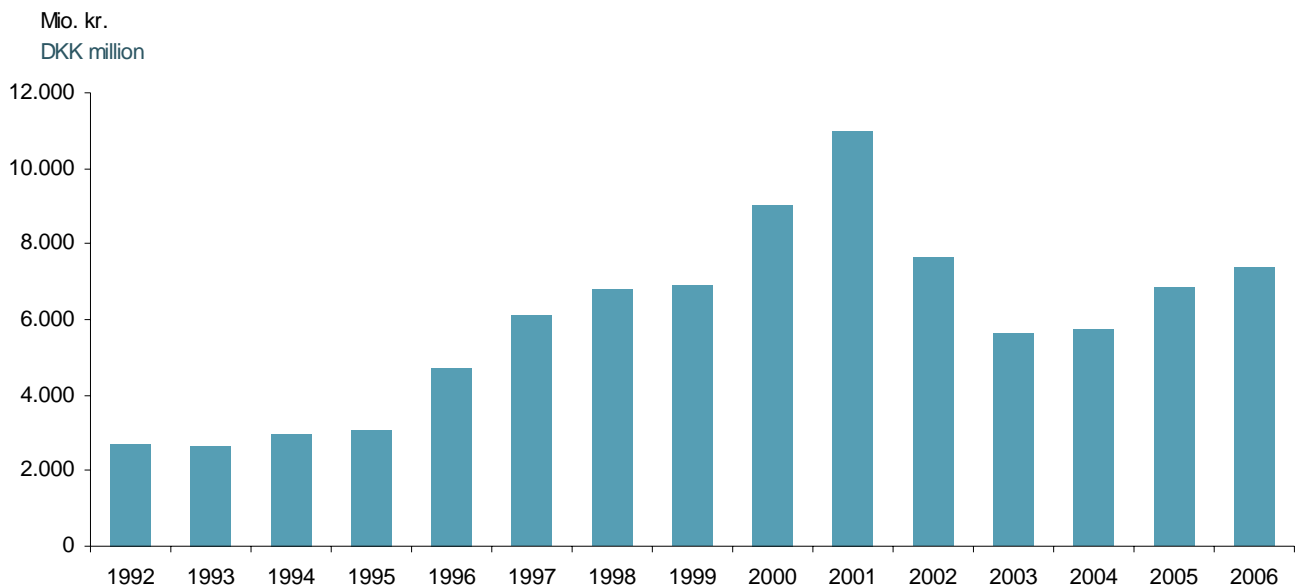

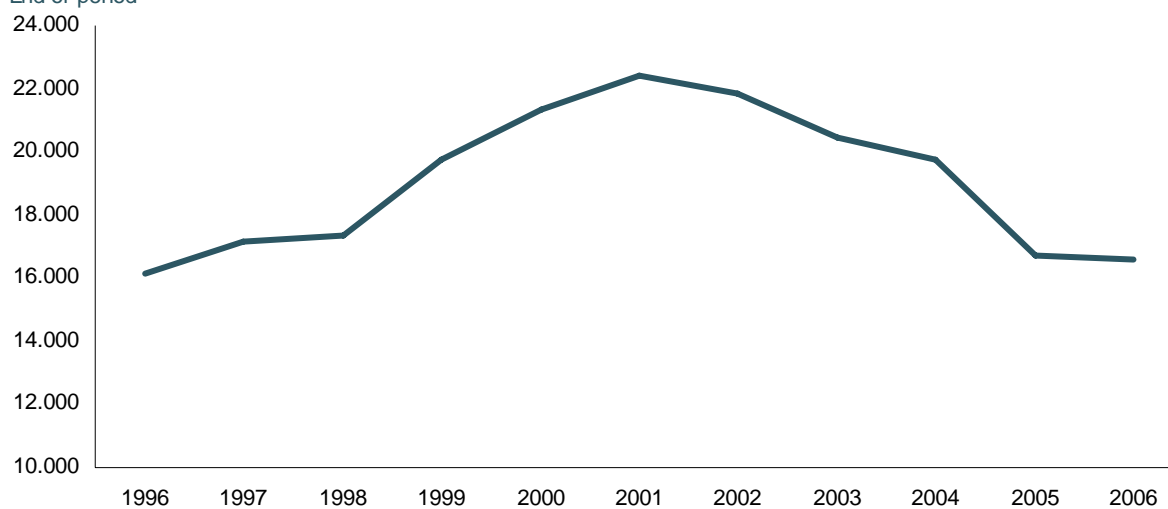
