Vedr, Nye oplysninger Scandinavian Star.

Rigsadvokaten har ved afgørelse af d 28 januar 2005, afvist at genoptage efterforskningen af ejer og operatørforholdet til skibet MV Scandinavian Star.

Rigsadvokaten har bla bygget sin afgørelse på, at skibet var overtaget, af selskabet KS-Scandinavian Star et dansk kommanditselskab på Frederiksberg, som var kontrolleret af Henrik Johansen.

Rigsadvokaten har også lagt vægt på at selskabet KS Scandinavian Star havde vidreudlejet skibet til Project Shipping Ltd og at dette selskab, igen vidreudlejede skibet til VR Dano aps. begge selskaber skulle ligeledes være ejet og kontrolleret af Henrik Johansen.

Told og Skattestyrelsen foretog en sideløbende undersøgelse, af samme forhold og Skat fandt at man også her måtte anderkende skibet som overdraget og overtaget af selskabet KS-Scandinavian Star d 30 marts 1990.

Rigsadvokaten har envidere anført, at det forhold at ejerskabet først endelig blev registreret i Bahamas Skibsregister i London må anses som naturligt, i relation til ventetid på at få lyst et skøde.hvorfor dette først skete d 30 august 1990.

Bahamas skibsregister, har i en række tilfælde lavet udskrifter mv, som er modsigende,i tiden fra 1990 til 1996.

Men i 2003 beder den danske ambassadør i Canada, Bahamas stat på Bahamas im at oplyse om navne på alle selskaber som har fremstået som ejer og eller operatør af skibet Scandinavian Star før under og efter branden. Og svaret kommer fra Bahamas regering d 11 februar 2003.

Heraf fremgår det således at, KS Scandinavian Star”det danske selskab” ALDRIG er blevet ejer og eller operatør af skibet MV Scandinavian Star, hverken før under eller efter branden.

Dertil vil jeg bede rigsadvokaten oplyse mig om, grundlaget for at antage at Henrik Johansen var skibets ejer og eller reder.samt grundlaget for at påstå Henrik Johansen Ole B Hansen og Hugo Larsen straf,som ejer-reder samt direktør og kaptajn.

Rederforholdet i denne sag hører unægtelig sammen med ejerskabet, men idet at KS.Scandinavian Star aldrig blev ejer, kan hverken Project Shipping Ltd eller VR Dano Aps have lejet skibet af KS-Scandinavian Star selskabet.

Der skal således ikke herske nogen tvivl om, at forklaringerne, om ejer og driftforhold fra starten, hænger sammen med kaskodækningen og P&I dækningen fra, forsikringsselskaberne.


Man skal huske på at Seascope ikke havde nogen selvstændige forsikringer på skibet,
