This Day has always been a highlight of European Parliament's activities in the field of equality between women and men. Every year, this moment of celebration and reflection is an occasion to raise awareness on the persistent gender gaps in our societies.

For the year 2008, the conference will focus on the European Year of Intercultural Dialogue.

You will receive a draft programme shortly, along with a practical note for the conference.



The meeting will take place on 6 March, from 9.00 to 18.00 in the Hemicycle of the European Parliament, Building Paul-Henri SPAAK, Rue Wiertz 60, 1047 Brussels.

Each national Parliament is invited to send a delegation of six members in order to facilitate the representation of bicameral Parliaments as well as to enable majority and opposition to be represented. According to the established practice, parliamentarians can be accompanied by administrators (one per two Members). The composition and the details of the delegation should be sent to the following e-mail address IP-FEMM@europarl.europa.eu as soon as possible and **no later than 14 February 2008**.
