Dear Mr. President,

I have the pleasure of inviting your parliament to take part, as an observer, in the Conference on *Africa and Migration: challenges, problems, solutions* to be held in Rabat (Morocco) from 22 to 24 May 2008. The Conference is being organized by the African Parliamentary Union (APU) in partnership with the Inter-Parliamentary Union (IPU) and in cooperation with the International Labour Office (ILO), the International Organization for Migration (IOM) and the Office of the United Nations High Commissioner for Human Rights (UNHCHR).

Given the enormous increase over the past 50 years in the movement of people across borders in search of employment, migration has moved to the top of policy agendas in many countries of origin, transit and destination, and it has consequently become a major challenge for African policy makers. The primary objective of the Conference is therefore to deliberate on those challenges and the ways and means of managing migration for the mutual benefit of society, migrants and African States. Please find attached the draft programme of the Conference.

As is indicated, the question of the participation of migrants in host societies and combating discrimination will also be addressed. Given the importance of these questions for your country, we hope that your parliament will be able to send a delegation to the Conference to participate in the relevant debates and thus to bring the point of view of receiving countries to the fore.

## 2. ENTRY VISAS

When required, the visa will be delivered free of charge to delegates, in the diplomatic and consular representations of Morocco.

In exceptional cases, for the delegates of the countries where there are no Moroccan diplomatic or consular missions, the visa will be delivered to them on arrival in Mohammed V International Airport in Casablanca or at Rabat International Airport. In such cases, delegates are kindly requested to communicate, by fax, to the National Group of Morocco the number and nature of their passports as well as the flight number, the date and hour of arrival in Morocco.

## 3. DOCUMENTS

On the occasion of the **African Parliamentary Conference On: "Africa and Migration: challenges, problems, solutions"**, delegates will receive their identification badges and briefcases containing the documents of the Conference (programme, Conference guide-book, invitation cards, working documents, etc.)
