

Excellency,

We are very pleased to inform you that the European Parliament in Brussels will host the World e-Parliament Conference 2008 on 25 and 26 November 2008.

The World e-Parliament Conference 2008 is co-organized by the European Parliament and the Global Centre for ICT in Parliament, a joint initiative of the United Nations, the Inter-Parliamentary Union, and a core group of partners, established in 2006 to promote the role of parliaments in advancing the effective use of ICT for the modernization of parliamentary processes.

The World e-Parliament Conference 2008 represents a unique opportunity for leaders and members of parliaments, parliamentary officials and experts to exchange views at a global level on the impact of new technologies as tools to strengthen the representative, legislative and oversight functions of regional and national assemblies.

The event builds on the results of the World e-Parliament Conference 2007, held in Geneva in October 2007, and on the outcome of the World e-Parliament Report 2008, the first publication on this topic issued by the United Nations, the Inter-Parliamentary Union and the Global Centre for ICT in Parliament on 28 February 2008.

The World e-Parliament Conference 2008 is principally aimed at members of parliaments, secretaries general, parliamentary staff and officials, experts from international organizations and academics who work and deal with information and communication technologies as instruments to improve and modernize parliamentary business and citizens' participation in public decision-making processes. It is the world forum to learn about and analyze good practices, network with peers and build partnerships in an international setting.

Around 400 participants will take part in the general debate and parallel tracks forming the World e-Parliament Conference 2008. Presentations will be delivered by parliamentary leaders, renowned experts and parliamentary officials to showcase cutting edge solutions and case studies.

A number of key organizations, institutions and universities are currently joining the coorganizers to support the organization of the event.



World e-Parliament Conference 2008

25 – 26 November 2008 European Parliament Brussels

In October 2007 the World e-Parliament Conference 2007 brought together for the first time members of parliament, secretaries general, IT professionals, and other parliamentary staff from around the world to address the promises and challenges of ICT in parliament. Speakers and participants shared insights based on experiences in their respective countries and regions and demonstrated the value of an ongoing global exchange to promote the benefits of ICT for parliaments everywhere.

Building on the excellent results achieved with the first World e-Parliament Conference 2007 and on the findings of the World e-Parliament Report 2008, the Global Centre for ICT in Parliament intends to organize an even more ambitious World e-Parliament Conference 2008.

The Conference will be organized in cooperation with the European Parliament which will host it in Brussels on 25 and 26 November 2008.

While the World e-Parliament Conference 2007, through its structure and the confluence of key stakeholders, offered a unique opportunity to identify what the emerging innovative trends and the barriers to effective implementation of e-parliament are, the focus of the World e-Parliament Conference 2008 intends to shift towards how e-parliament can be achieved.

In line with the above the Conference will provide a platform for presentations and exchange of experiences on:

- a) Concrete solutions for improving parliamentary business and supporting representative, legislative and oversight functions
- b) The adoption of practices and approaches which support their implementation process.



The expected outcome of the World e-Parliament Conference 2008 are to:

- Establish a community of practice among members and staff responsible for information and communication technologies (ICT) in parliament.
- Engage parliaments from all regions of the world in fostering inter-parliamentary exchanges on ICT bilaterally, regionally, and globally.
- Identify standards designed to encourage the most effective us of ICT in parliament.
- Set future achievable goals for enhancing the global state of ICT in parliaments at all levels.
