Dear Speaker, dear Colleague,

In the second half of 2009, Sweden will assume the Presidency of the European Union Council.

During the Swedish Presidency, the Riksdag will host interparliamentary meetings on themes linked to the Swedish priorities for the Presidency. Therefore we foresee discussions on subjects such as *environmental policy and climate change, financial sustainability, the Baltic Sea Strategy*, as well as *the Stockholm programme*. The latter in parts related to the fight against crime. One of the meetings will also address *equal opportunities* between women and men.

The meetings will be held in the Riksdag buildings in Stockholm, except for the meeting of the Chairpersons of Committees on Foreign Affairs, which will take place in Visby, on the island of Gotland.


During the Swedish Presidency, we also expect, as is customary, to host joint parliamentary meetings together with the European Parliament. Further information about these events will be sent out later.

I would also like to take this opportunity to inform you that the annual *Conference of the Speakers of the European Union Parliaments 2010* will take place in Stockholm on 14-15 May. Furthermore, I plan to invite the current extended troika of EU Speakers to Stockholm on 8 July 2009.

It gives me great pleasure to welcome representatives from your Parliament to the meetings listed below.
