Climate change and the shipping industry of tomorrow Maritime event at Nordic Climate Solutions, September 9, 2009 1 - 2.30 pm (Room 16)

Deloitte is organizing a maritime event to take place at the Nordic Climate Solutions Conference in Copenhagen (Bella Centre), September 9.

Context and purpose

A recent study commissioned by the International Maritime Organization (IMO) estimated that ships engaged in international trade contributed about 2.7 per cent of the world's anthropogenic CO2 emissions in 2007 (*). The study also found that emission reductions are feasible through technical and operational measures, as well as through the introduction of marketbased instruments.

However, in the absence of global policies to control greenhouse gas emissions from international shipping, the emissions may increase significantly over the next decades due to the expected growth in international seaborne trade – despite the present economic downturn.

Danish shipping companies work proactively through national and international organizations to reduce CO2 emissions and other air pollutants from international shipping. It is vital to the industry that solutions are global in nature and apply to all, independently of the flag state. The IMO therefore wishes to continue its work on regulating the CO2 emissions from international shipping.

(*) Prevention of Air Pollution from Ships, Second IMO GHG Study 2009. A proposal by the Danish Maritime Authority suggests that the best and most efficient solution will be the development of an International Fund for Greenhouse Gas Emissions from Ships for addressing the global climate problems, as well as providing incentives for research and development.
