Jeg vil hermed bede Europarådet støtte min ytringsfrihed. Jeg kritiserede UN's "Kyoto" klimamodel, som blev markedsført af Al Gore i "an inconvenient truth" og af minister Connie Hedegård i Gladsaxe Bio, 28-3-2007. Jeg beskrev det som "Den bekvemme politiske løgn" i Gladsaxe Bladet, 10-4-2007. Jeg blev derefter underkastet censur. Mere end to år senere blev min kritik gentaget i Frederiksborg Amts Avis fra et EU møde som "En bekvem politisk klimaløgn", 25-5-2009. Derefter fortsat censur, der er også er rettet mod de mange andre "Kyoto" dissidenter.

UN's "Kyoto" model strider mod min "Polar Nat" model. Min "Polar Nat" model forudsagde allerede i sommeren 2008 en hård vinter for December 2009. Dette blev bekræftet netop som COP-15 mødet sluttede. Polar Nat modellen er baseret på Nord Atlantens strømsystemer. Den nødvendige viden til en præcis forudsigelse blev ødelagt med Den danske regerings universitetslov i 2003. De stumper om klimaet, jeg har her, antyder misvækst fremover.

Europarådets målsætningen er at styrke demokrati, ytringsfrihed og menneskerettigheder. Et resultat af ytringsfriheden er den videnskabelige revolution, der er grundlaget for den europæiske civilisation og kultur. Ytringsfrihed imod den politiske magt kendes fra den græske oldtid.

Menneskerettigheder er kun et par hundrede år gamle tanker. Menneskerettighederne misbruges til at forlange ret til hvilke som helst grupper, der forlanger beskyttelse mod ytringsfrihed. I UN er siden 1960'erne dannet en gruppe, der hævder, at menneskets brug af kul og olie ændrer klodens klima, forøger luftens temperatur, der smelter polarisen og skaber oversvømmelser. Det er demokratisk vedtaget som UN's "Kyoto" klimamodel. UN støtter "Copenhagen Accord to climate change". Kritik af "Kyoto" model nævnes ikke.

Jeg har forsøgt at komme igennem med min kritik i Danmark, Folketing, Ombudsmand, medier, universiteter oa.. Jeg skrev tilsidst til alle EU parlamentarikere om at støtte ytringsfriheden. Jeg har mange positive svar fra "Kyoto" kritikere, som ikke har ytringsfrihed. Jeg beder Europarådet sende mig en liste over medlemmernes navne og adresser, helst post. Internettet er ikke præcist.

## Free Speech for Polar Science against "Kyoto" fake

Dear EU parliamentarians

11-2-2010

**Please, stop the new EU commission's suppression of the free speech to criticize UN's "Kyoto" climate model, and stop EU's support to a finance model on a "Kyoto" fake.**

At first I owe thanks to many EU parliamentarians, UKIP MEP, climate-sense @ live, CFACT, NIPCC, "Copenhagen Climate Change", "Alternativ Konference" and many other "Kyoto" dissidents during COP-15, because I was not alone against the "Kyoto" climate model.

The Danish minister, Connie Hedegaard, introduced, **28-3-2007**, Al Gore's "an inconvenient truth" with UN's "Kyoto" climate model and a "climate crisis" due to warm airs melting of the polar ice. That is impossible, only warm Ocean currents can melt the polar ice. I described it as "A convenient lie" in letter to our local editor, 10-4-2007. I also criticized the university sciences and I expected a correction of fatal errors in the "Kyoto" model. My later newspaper notes explained the "**Polar Night**" model and UN's "Kyoto" model as a religion. They closed the year 2007. I soon after discovered the EU censorship executed by the Danish government.

The year **2008** started with a heavy campaign for the "Kyoto" model supported by the Danish Government, medias, NGO's etc. Yale President Richard Levin supported Al Gore in a lecture at the University of Copenhagen, where Prorektor Lykke Friis excluded my protest, 18-1-2008. The EU commission's Danish headquarters in "Europahuset", Gothersgade 115, DK-1123 Copenhagen K was and is still stuffed with propaganda for EU's and UN's "Kyoto" model. My "Kyoto" critical articles were like many others "Kyoto" dissidents omitted from the EU headquarters.

At last I asked, **7-5-2009**, the former EU parliament and, **8-6-2009**, the EU Agency for Fundamental Rights (FRA) to secure my rights of free speech to criticize UN's "Kyoto" climate model. The EU offices treated my questions fast and divided them into the sciences and into the right of free speech, ref letters of, **7-7-2009**, **13-10-2009**, **11-11-2009**, **23-11-2009**.

The scientific criticism of UN's "Kyoto" climate model compared to the "Polar Night" model is referred to the Committee for Environment, Health and Food. The "Polar Night" model is developed from quantitative energy flows in fisheries from NW. Greenland, to the North Sea, to Thailand and from hunting statistics. **The "Polar Night" model** explains e.g. the quantitative food chains between the Arctic fishery on Greenland Halibut and the Tropical fishery on Tuna.

**The "Polar Night" model forecasted**, **10-10-2009**, COP-15 to end with snowstorms for the coming hard winter in 2009/2010. The forecast is based on changes in the summer 2008 in shallow water ecosystems and on observations on whale, fishes etc in the Baltic. These changes are similar to changes in 1930-32, then due to changes in the North Atlantic currents. Estimates from comparable old records forecast harder winters for the coming 4-6 years. It is already confirmed by a Walrus visiting West Jutland, **5-2-2010**, and by the warm winter 2010 in West Greenland known to alternate with the present strong winters in Europe and Atlantic USA.

The EU (FRA) refers the rights of free speech to the Danish "Folketing" and its "Ombudsmand", **7-7-2009** and thus returns it to the EU member states. The Danish "Ombudsmand" cannot enter the question on right of free speech, **4-11-2009**, due to the Danish laws. The EU commission and USA criticize other nations for the suppression of free speech. **Question for the EU parliament?**

**Dear EU Parliamentarians, UKIP MEP, climate-sense @ live, CFACT, NIPCC, "Copenhagen Climate Change", "Alternativ Klima Konference" and many more "Kyoto" dissidents.**

I owe thanks to all, because I am no longer alone against the world of "Kyoto" believers. I was excluded from Danish medias, journals and universities since 10-4-2007, when I called Al Gore's "Kyoto" climate model a "convenient politically lie". The Danish climate minister Connie Hedegaard introduced Al Gore. My "Kyoto" criticism against Yale President Richard Levin was excluded from University of Copenhagen by prorektor Lykke Friis, 18-1-2008. At last I asked the EU parliament, 7-5-2009, to secure my rights of free speech to criticize UN's "Kyoto" climate model. EU accepted it.

The Danish Conservative Government, its Socialistic Opposition, the NGOs and all medias believe in "Kyoto". This Danish establishment acts on behalf of the European Commission and of UN. The Danish Government appointed Connie Hedegaard as EU climate commissioner and Lykke Friis as climate minister. **Hence rights of free speech for "Kyoto" criticisms is still far away.**

The COP-15 finally collapsed, but UN's "Kyoto" climate model still exists. It violates all scientific rules and concludes, that higher air temperature melt the polar sea, increase the sea level and cause the "climate crisis". UN ignores experts like Professor Ole Humlum, Oslo, (temperatures) and Professor Nicklas Mörner, Stockholm, (sea level), both published "Kyoto" critical papers in popular books. The Polar Night climate model is published in textbooks and popular books.

Only few peoples, politicians, bureaucrats etc. in UN and EU know the Polar night, the Midnight sun and the Polar Circles. Only around half a million people live north of the Arctic Polar Circle and none south of the Antarctic Polar Circle. The biggest Arctic town, Murmansk, ca. 200.000 inhabitants, is free of ice all year round, due to a branch of the Golf current. It is on the same latitude as Disko and Illulisat glacier, where Connie Hedegaard had her ice diplomacy during the past summers.

At Illulisat, 70° North, with a 6 weeks Polar night in December-January and with a 6 weeks, 24 hours Polar day, in June-July, the low summer sun with only ca. plus 3-9° C air temperatures cannot compensate the heat loss during the Polar nights, with air temperatures at minus 20-40° C. The Polar nights coldness is accumulated during million of years in the permafrost, in the Ice caps and in the deep Polar Oceans. The rich marine life in the deep Arctic Oceans with minus 1.5° C is utilized by man, seals, Walrus, polar bear etc. The important arctic fishery for Deep Sea Prawns, Greenland Halibut, Redfish etc. is known from shops and restaurants..

Contrary to the few Arctic peoples, millions of peoples live along the Equator, between the Tropic of Cancer and the Tropic of Capricorn and the Subtropics. They have the sun above their heads at noon every day with a fast sun down. They cannot imagine, that their climate, temperature and sea level are dominated by a polar night and a polar day every half year.

**The periodicity in the Polar Night climate model predicted, 14-10-2009, that the period from ca. 2001 to 2008 of rather warm years would be followed by strong winters from 2009/2010. The COP-15 ended 18-12-2009 with snowstorms.** There are now January 2010 strong winters on the northern globe. A more precise forecast is inhibited, because the necessary knowledge was closed or splitted up by the Danish government's university law of 2003.

Please, investigate my case on suppression of free speech on sciences, finance, medias etc. by Danish politicians. The suppression of free speech is otherwise common in EU, USA and UN. Hence, I add my thanks, 6-1-2010 to the many "Kyoto" dissidents in similar situations.

Denmark became in the spring of 2007 invaded by Al Gore's "an inconvenient truth" and his promotion of UN's "Kyoto" climate model introduced by the Danish Climate minister Connie Hedegaard. I referred it, 10-4-2007 as "a convenient politically lie", and introduced the "Polar Night" climate model. The Danish Government and medias suppressed all later "Kyoto" criticism. The medias referred only once the "Kyoto" criticism in: "A convenient politically climate lie", 25-5-2009. I wrote to Danish authorities and at last to EU.

I asked, 7-5-2009 the former EU Parliament to secure my rights of free speech both as citizen and as polar scientist to criticize UN's "Kyoto" climate model. Its conclusion: a "climate crisis" from fossil fuels, carbondioxid, warm air with melting of Polar ice and increasing sea level, is false. The heat loss during the polar nights cannot be compensated by warm air, greenhouse effects, solar heat or any other source. I asked after the election of the new EU parliament the Danish EU-MEP to secure my rights of free speech to criticize UN's "Kyoto" climate model. Only the Danish EU-MP, Morten Messerschmidt answered immediately and positively. I asked, 8-6-2009 the EU Agency for Fundamental Rights (FRA) to secure my rights of free speech to criticize UN's "Kyoto" climate model. My questions to EU are treated positively and divided into the scientific question and into the human rights question. The scientific criticism of UN's "Kyoto" climate model is referred to the Committee for Environment, Health and Food. The EU (FRA) refers the rights of free speech to the Danish Folketing and its "Ombudsmand", 7-7-2009.

The Committee for Environment, Health and Food may have qualified experts to evaluate the "Polar Night" climate model. They can calculate balance sheets on the annual loss and gain of heat in the polar areas (North and South). A section of the "Polar Night" model explains the climate difference between the Arctic fishery on Greenland Halibut and the Tropical fishery on Tuna. It is developed from quantitative energy flows in commercial fisheries from NW. Greenland, North Sea and Thailand. It also includes the hunting statistics from Greenland.

The EU (FRA) limits the right of free speech to the member states. My case was already at the institutions in, 11-11-2008 and, 23-11-2008. It is later, 7-7-2009 and, 13-10-2009, returned to Denmark. EU (FRA) they cannot deal with rights of free speech in the EU states.

The "Polar Night" model forecasted, 10-10-2009, that COP-15 would end with snowstorms for the coming hard winter in 2009/2010. The forecast is based on studies during the summer 2008 on shallow water ecosystems in the Baltic. They and other observations, whale, southern fishes, confirmed a change in the North Atlantic similar to 1930-32, when the shallow water "eelgrass (*Zostera marina*) community" died. It was a catastrophe for some factories in Holland. Unfortunately, such observations are no longer collected, compared or repeated. However, our best forecast from comparable old records is harder winters for the coming 4-5 years.

I call on the EU leading authorities to set up independent commissions to clear up the widespread political censorship on free speech for medias, for scientists and citizens in EU, USA and UN.

Let me present the UN climate meeting in Copenhagen in December 7-18-2009 as a competition between the validity in the weather forecast from the two climate models.

### **Competition between two weather forecasts climate models**

**UN's "Kyoto" model:** The use of coal and oil increase the content of greenhouse gasses, the greenhouse effect and the air temperature. Result: climate crises with melting of polar ice, glaciers, increase in sea level, flooding etc.

The climate forecast: increasing use of coal and oil, increasing air temperature, increasing melting of polar ice, flooding etc. for the next decades.

Consequences: Control and tax on human activity. Science returns politically to before Galileo

**Polar nights model:** Million of years with polar nights created the deep, polar oceans, the polar currents and the polar life systems. The solar system controls the polar nights and their influence on the global climate in periods from tens, to hundreds, to thousands, to million of years.

**The climate forecast:** the rather warm 2000 to 2009 period is followed by longer periods with

**Ice winters from 2010 to 2020.** Similarity to the 1920er, the 1930er, 1940er, 1950er, 1960er  
Consequences: Clever adaptations to the colder and changing climate.

**A semifinal competition between the two weather forecast models will be at UN's climate meeting 7-18. December 2009. The final competition will be in 2020. Referees not appointed.**

**The "Kyoto" model** started early in 1958 and with increasing support in the 1960ies culminating in the year 2000, when Al Gore as ex-president took up the "Kyoto" climate model. He spread the message of a "climate crisis" in his book and film: "an inconvenient truth". He relied on a few "scientists" with few trustworthy measurements. His was repeated by ideologists like James Lovelock, Tim Flattery etc. with the "Gaia" philosophy. Al Gore received huge support from finance, medias, friends, NGO's with "save the world", "protect the nature" and similar ideology. They say, that critical scientists are "climate criminals" and paid by the industry. He and his team received the Nobel Peace Prize in December 2007.

**The polar night model** started slowly. Few understood the financial bureaucracy in the "Kyoto" climate model. The scientists: Professor Ole Humlum, Oslo and Professor Nicklas Mörner, Stockholm showed the errors in "Kyoto". Many ordinary people became "Kyoto" dissidents.

The Danish minister Connie Hedegaard introduced "Kyoto" and Al Gore's: "an inconvenient truth" in our local cinema 28-3-2007. Al Gore omitted the heat loss during the polarnights, and. I described the film as "a convenient lie", 10-4-2007. From that day all "Kyoto" critics became censured. "Kyoto" lectures in the University of Copenhagen started Monday 21 January 2008 with President Richard Levin, Yale University. He admired the financial value of CO<sub>2</sub>, the taxes, the surveillance, punishments and bureaucracy in the "Kyoto". The audience of students of law, politics, economic, sociology and similar people agreed. "Kyoto" critic was omitted.

At last I asked the EU parliament 7-5-2009 to secure my right of free speech to "Kyoto" critics. It was cited in the Danish medias only once in the courageous "Frederiksborg Amts Avis" 25-5-2009 as "A politically climate lie". Finally, the chairman of the Danish Parliament broke the censorship 9-9-2009 in a talk in the Parliament and criticized "Politically research". A hard debate followed.

For bookmakers: "Polar Night" forecasted the hard winter 2009/10. Forecast for the years: 2011, + 2012, + 2013, + 2014: Hard winters and warm summers Tru ???

## Den bekvemme politiske løgn

Jeg har netop set Al Gores film „Den ubekvemme sandhed“. Det var en lang omgang intern amerikansk politisk kampagne, der var baseret på UN's „Kyoto“ model. # En bekvem politisk klimaløgn

Jeg har bedt EU-Parlamentet sikre min ytringsfrihed som EU-borger og som polarforsker. Min klage er sendt til Dan Jørgensen og Anne E. Jensen. Let me follow up the mail from 29-1-2010, where I described the fight, I had for the Polar Night model against the Kyoto climate model. I will here try to develop the Polar night model from the latest news.

The many earthquakes reported from the Andes, Haiti etc. and lately the vulcanic ashes from Iceland may be a consequence of the Polar Night model. Of course I have not and cannot get sufficient documentations except the media reports. However, I looked again on the correspondance from Hans Jürgen Bobzien from the years up till his death 25-10-2007. From these papers I expand the Polar Night model to be used for the melted magma. The melted magma obey the same astronomic forces as the oceans. They result in eddies, currents, different densities etc. in the magma. The continental plates may be taken as frozen magma and behave as sea ice in the oceans. I see the Drakes passage and the Carribean as results from magma currents similar to the local ocean currents. The mountain ridges like the Andes are in the Tertiary time pushed up by the tides, like the Arctic polar currents are pushed up against the east coasts. In older geological periods the ecliptic plane had other directions and hence other astronomic forces. Hence the changes in the ecliptic could be calculated from old mountain ridges and vulcanoes.

I knew, that geophysiciens and astronomers have a religious belief in the old fixed Newton model of the solar system. I demand, that they include the biological, paleontological and geological informations. I pointed out from 1984 the conflict between biology and geophysics. However, they and the astronomers ignore the biological facts. They believe in the Gaia religion and look for life in space. I study just a small part of the life systems on this earth and its dependance on the moon and the sun. I knew, that ice ages can be traced back in the precambrium. However, I stick to the most modern times with the best informations. However, I miss a smaller iceage for the "fishclay" deposit between Cretaceous and Tertiary. I knew the stupid Alvarez geological explanations of the Yucatan meteor, that ended the Dinosaurs periods. They do not explain the origin of the fully developed Tertiary ecosystems, which suddenly appeared 65 million years ago. So much for my view on some of the geophysicists.

I finished this week to send my plea to the more than 700 EU parliamentarians. It is depressing to observe, that only a few have knowledge in the "hard" sciences, eg. medicin. technique etc. The majority are different politically disciplined bureaucrats, journalist etc. The old european civilication, with questions to everything is called off. Well evrything has its time.

Give all my regards to IPÖ. I hope you dare tell them, that you knew dissidents like me and Hans Jürgen Bobzien.

I have just collected part of our emails and letters from ca. 2006 to 2009. It would be an interesting book for future historians on biology. I also corresponded with several "Kyoto" dissidents during 2009. I outlined a competition between "Kyoto" and the "Polar Night" climate models and predicted, 14-10-2009, ice winters for the coming season. As I expected, the COP-15 ended with snowstorms, and now we expect icewinters. The icebreakers are standing by.

This forecast is more than luck. Actually, you and our colleagues in the Baltic, from Denmark to Finland were involved. Jørgen Lützen and I wanted samples of the small *Cardium hauniense* for gonad studies in the summer of 2008. *C. hauniense* is eaten by flounders in brackish Baltic water. It used to be very common, but we could not find enough. Hence we wrote to you and colleagues in the Baltic. We went to Michael Zettler in Warnemünde.

We noted a recent change in the beach communities from a *Fucus* to a *Zostera* community. We had both worked in Isefjord and in Arctic Station, Greenland. We knew the old discussion with Chr. Vibe and Erik Rasmussen on the environmental changes from the North Atlantic currents. The sudden death of *Zostera* in ca. 1930 was followed by the warmer 1930er ending with the icewinters in 1940er. We saw now a similar pattern and could actually forecast the snowstorm in december 2009 already after our visit to Warnemünde. The forecast, 14-10-2009, was more than a wild card. Unfortunately, all the old records are more or less forgotten, not followed up, or burnt. (NOTE, I dare not yet compare climate changes with financial crisis).

You know, that I in 1970erne compared quantitative food chains from West Greenland with the North Sea and concluded large changes in solar systems. I have tested the conclusions with other seas, it fitted. Only Al Gore's "Kyoto" woke me up. Any hot air cannot melt the polar ice. That is a "convenient politically climate lie". But it is accepted by UN and EU politicians. It is an exercise for Angelika Merkel as a physicist to calculate balance sheets for the yearly loss and supply of heat in the polar regions. BUT, that is forbidden science, and she believes in the mystic Schnellenhuber. Hence I want EU to secure free speech. Do you know German EU parliamentarians, who defend right of free speech?

I have seen the paper "ICES Insight, no. 46, September 2009. I read the articles as a conflict between the old, world wide, free science ICES organisations and the modern politically, financial controlled and restricted EU "science", supported by semireligious NGO missionaries. Jens Smed and Gotthilf Hempel are from the good old days.

Gert Verreest: "Good environmental status: from dream to reality at last?" is a horrible example of modern EU science. His first demand for the good environment is "maintained biological diversity". The polar ecosystems are efficient, low diversity, food chains. The methods are now used all over the world for better food supply. Death of species is used both by nature and man, no hard feelings.

The UNCOVER project is called a marine puzzle. Christian van Dorian is engaged in it. Can you forward my opinion to the Institute of Baltic Sea Fisheries in Rostock?. I will forward this to Gerd Hubold here in ICES.

I miss Daniel Pauly's opinion on the Darwinian Fishery Management.

I hope, I have forwarded you my thanks to the "Kyoto" dissident at the COP-15. I have old IT machines and printers both at home and at the museum. Often I cannot remember what is where and sent. I cling to the old stuff as long as possible.
