**THE UNIVERSAL PERIODIC REVIEW: STOCKTAKING OF THE
CONTRIBUTION OF PARLIAMENTS**

Dear Mr. President,

In the two years since the United Nations Human Rights Council started its universal periodic review (UPR) of the fulfilment of human rights obligations and commitments by Member States, some hundred countries have reported and discussed efforts at home to promote human rights and taken on board recommendations for further improvement from their peers at the Council.

The IPU and the United Nations attach great importance to a strong contribution of parliaments to the work of the UPR. Parliaments can provide essential input by discussing the draft national report before it is submitted to the Council, by taking part in the national delegation presenting the report to the Council, and by overseeing the implementation of its recommendations. Last year, the IPU carried out several initiatives to promote knowledge of the UPR among parliaments and to encourage parliamentary involvement in the process.
