Dear Colleague,

The development of a European area of justice, aiming at facilitating the daily life of EU citizens and their families in the ever-increasing number of cross-border situations, is a priority of EU action in the field of civil law. In the context of the new legal and institutional framework established by the Lisbon Treaty, ambitious initiatives in the interest of citizens and their families can be developed only through the participation of both the European Parliament and the National Parliaments in enhanced dialogue and collaboration.

For this reason, the Committee on Legal Affairs and the Policy Department on Citizens' Rights and Constitutional Affairs of the European Parliament are organising an interparliamentary workshop on family law with the participation of representatives from the National Parliaments, which will take place on Tuesday 30 November 2010, from 9h30 to 18h30, at the European Parliament premises in Brussels.

The aim of this interparliamentary workshop is to launch a reflection and debate on action that should be taken to respond to the needs and expectations of European citizens and families, with the view of facilitating their lives in cross-border situations. To this end, the contribution of the representatives of your Parliament will be most fruitful.

It is thus my pleasure to invite up to four Members of the relevant committees of your Parliament (two for each Chamber of National Parliaments composed by two Chambers) to participate in the workshop.

Please find enclosed a preliminary draft programme containing a list of topics, which will be discussed at the conference. The final programme and more detailed practical information for the event will soon be forwarded to your Parliament's Representatives/Services responsible for relations with the European Parliament.

I sincerely hope that you will be able to accept my invitation and look forward to welcoming you to the European Parliament.

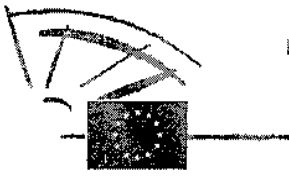
J'espère sincèrement que vous serez en mesure d'accepter mon invitation, et je me réjouis d'ores et déjà de vous accueillir au Parlement européen.

## **BACKGROUND, AIM AND CONTENTS OF THE INTERPARLIAMENTARY WORKSHOP ON CIVIL JUSTICE: "HOW TO FACILITATE LIFE OF EUROPEAN FAMILIES AND CITIZENS?"**

Given the increasing mobility of EU citizens and their family members, it is of paramount importance to remove the legal and administrative barriers that citizens still face when they start a family life in a Member State other than their own. Free movement is a core right of EU citizens and their family members. It therefore needs to be enhanced and rigorously enforced.

With the entry into force of the Lisbon Treaty, the Union now has the tools to respond to the needs of European citizens and their families in order to make their daily lives easier in cross-border situations. The Union is therefore called upon to eliminate the current legal uncertainty for international couples deciding to divorce or separate, for international successions, as well as children and their parents in cross-border situations. The Union can further help remove obstacles to the recognition of legal acts and enable the mutual recognition of the effects of civil status documents, in view of making European citizenship a tangible reality.

In the new legal and institutional framework established by the Lisbon Treaty, ambitious initiatives in the interest of citizens and their families can be developed only through the participation of both the European Parliament and the national parliaments in enhanced dialogue and collaboration.

Against this background, the aim of the interparliamentary workshop on civil justice is to gather members of the European Parliament and national parliaments around the same table in order to discuss and reflect upon action that should be taken at EU level to respond to the needs and expectations of European citizens and families.

The workshop will be composed of four thematic sessions. The first two sessions will present the "state of play" in the drafting of new legal instruments in the field of European family law and the law of succession. The third session will focus on child protection in cross-border situations. The topics of parental responsibility, including the controversial issue of the recognition of surrogacy agreements, as well as of international adoption will be addressed therein. Legal practitioners and academics will report on the current situation as it stands in several Member States. Finally, the last session will provide an overview of the current difficulties faced by citizens in proving their civil status in cross-border situations. In this regard, a number of actions ranging from the suppression of the legalisation formalities of civil status acts to the interconnection of civil status registers will be presented. The challenging idea of creating a European "civil status" document will also be discussed.
