The UN was established on unjust foundations by the conquering states in the WWII. Other states' will was neglected, and the organisation was set to fit themselves and their interests only, and to safeguard their security. They request the rest of the world to accept it as it was designed by them. The result was moving wars from the yard of the super powers, which established the UN, to the other states in the world. Thus, 65 wars broke out after the establishment of the UN, not between the major states, but rather between the other states. In eight of these wars, the states enjoying permanent membership and the veto were parties against minor states with neither permanent membership nor veto.

The world raised it voice against this injustice and discovered that the UN and its Security Council are a tool in the hands of the major states to assault and terrorise the minor states. It began then to oppose to the UN resolutions, and the General Assembly was not paid same attention as before, sine it is merely a décor (another Hyde Park). Voices were thus raised to reform the UN, because it is inefficient.

The dangerous thing is the deviating of the reformation course, leading it to be itself another injustice of great magnitude. If reformation deviates and only means increasing other major states to the current major states in the Security Council, then the minor states would only be crushed even more, and the level of tension and inequity will increase all over the world.



The reformation that we, the minor states constituting the majority in the world, must realise, adhere to and even impose is:

Firstly: Transmitting the powers of the Security Council to the UN General Assembly, since it is the parliament of the world. The Security Council will only implement the General Assembly resolutions, since it is the legislator, and the only binding resolutions are those of the General Assembly. This is the traditional democracy the world is following.

Secondly: Re-structuring the Security Council and enabling its membership to all states, in order to be represented by the different assemblies or unions. In such a way this organisation becomes truly international; for example the EU can have one permanent seat, the Russian Federation one permanent seat, the American Union (USA) one permanent seat, the AU one permanent seat, Latin America one permanent seat, as well as ASEAN and SADEC, since each and every one of these groups, assembly or union encompasses several states, and the seat would in such a case represent these states, instead of representing one state only using it merely to its own interests. Thus, the world's states would be represented in the Security Council, and the veto can either be abolished or made accessible to all assemblies or unions. The current veto dictatorship can not be allowed to continue.

This must be done only from within the General Assembly, which represents the world entirely. The discussions must begin immediately in order to achieve this international reformation.

Without it, no timetable can be set to achieve within its frames the eagerly awaited UN reformation.
