

Dear colleague,

The adoption of an optional instrument in the field of EU contract law, building on substantive academic work already carried out in the field, is now high on the EU agenda, and important steps in this direction would be taken in the coming months. Ambitious initiatives should be developed at EU level in the interest of business and consumers, commonly faced with the reality of cross-border transactions. The European Parliament will, once again, play an important role in this work, and is counting, to this effect, on an enhanced dialogue and cooperation with national Parliaments.

In this context, the Committee on Legal Affairs of the European Parliament intends to organise an inter-parliamentary meeting with participants from national Parliaments. The meeting will take place on Wednesday 27 October, from 9:30 to 13:00, in the European Parliament in Brussels.

I am convinced that, by then, we will have an additional basis for our discussions, as the Commission will have published its Green book on European contract law. I am equally certain that the representatives of your Parliament will make very interesting contributions.


I am thus very pleased to invite to this meeting a maximum of four members from the competent committees of your Parliament (two from each chamber for bicameral national Parliaments).
