Dear Colleague,

As a result of the entry into force of the Lisbon Treaty, the European Parliament will for the first time co-legislate with the Council on the next CAP reform, and is counting, to this effect, on an enhanced dialogue and cooperation with national Parliaments.

In this context, the European Parliament's Committee on Agriculture and Rural Development is organising an inter-parliamentary committee meeting with national parliaments to take place on Tuesday 12 July 2011 from 15:00 to 18:30 in the European Parliament's premises in Brussels.

The aim of this meeting is to discuss the future reform of the CAP on the basis of the European Commission's Communication on the CAP towards 2020^1 and the two European Parliament's resolutions (Lyon report and Deß report)² with a view of providing an input to the legislative proposals, which are expected to be presented by the European Commission in autumn 2011.

I am thus very pleased to invite up to four members from the competent committees of your Parliament (two for each Chamber for bicameral Parliaments). Should you be unable to attend we would welcome any written contribution which would be distributed to our respective Members and other participants.
