

Beluga Fascination flagged Antigua and Barbuda (signatory to MARPOL). BF has commited numerous breaches of MARPOL. Has also had instances of Voyage Data Recorder

Marpol 73/78 is the International Convention for the Prevention of Pollution From Ships, 1973 as modified by the Protocol of 1978. ("Marpol" is short for marine pollution and 73/78 short for the years 1973 and 1978.)

Marpol 73/78 is one of the most important international marine <u>environmental conventions</u>. It was designed to minimize pollution of the <u>seas</u>, including <u>dumping</u>, oil and exhaust pollution. Its stated object is: to preserve the marine environment through the complete elimination of pollution by oil and other harmful substances and the minimization of accidental discharge of such substances.

Marpol contains 6 annexes, concerned with preventing different forms of marine pollution from ships:

- Annex I Oil
- Annex II Noxious Liquid Substances carried in Bulk
- Annex III Harmful Substances carried in Packaged Form
- Annex IV Sewage
- Annex V Garbage
- Annex VI Air Pollution
