

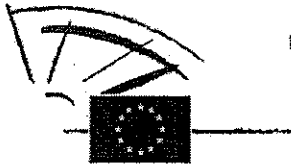


The aim of this meeting is to discuss the Commission's legislative proposals on the reform of the CAP with a view of providing an input for the next stages of the legislative procedure.
