## The path to sustainable health systems

Demand for health care will increase in the coming decades, which raises implications for fiscal sustainability.

## A global personalised medicine

*Can Europe lead the way?*

Personalised medicine calls for appropriate governance strategies at all levels as it challenges the way health care systems are set up. For instance, early molecular testing to identify the right treatment for each patient is transforming the clinical approach to cancer. Timely advice from policy makers and other stakeholders is needed to help prepare Europe for changes in how society deals with well-being, health, ageing, diet and disease.

- Personalised medicine – new scientific paradigms, organisational changes, regulatory issues and bottlenecks
- Public Private Partnerships – who are the drivers, what are the incentives?
- Access to personalised medicine – adding value for citizens and health systems?
- European policy making – leading the global way in times of financial crisis

## Non-communicable diseases

*From prevention policies to health systems response*

# Plenary Sessions



EHFG 2009 discussed "Financial crisis and Health" as European economies entered recession. We concluded that "policy leadership" and "resilience" of communities would be required to steer through the financial and debt crisis.

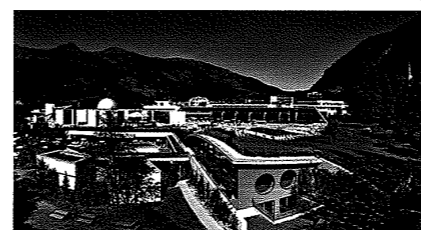
### Hallstatt and St. Wolfgang
