

Dear Ms Kjer Hansen,

Thank you for the letter of 7 December that you signed along with a number of other Chairs or Vice Chairs of parliamentary Committees on European affairs of several national parliaments.

I am delighted that you have embarked on a joint reflection on this matter, as it is indeed parliaments themselves, rather than governments, that must be in the forefront of developing proposals on how to assure democratic accountability in a deepened Economic and Monetary Union.

The European Council meeting of 13 and14 December 2012 concluded that "the general objective remains to ensure democratic legitimacy and accountability at the level at which decisions are taken and implemented". This means that both the European Parliament, vis-a-vis European institutions and procedures, and national parliaments vis-a-vis national governments (and their members of the Council), have a role to play. Cooperation between both levels can contribute, and this must be determined jointly by the European Parliament and national parliaments in line with Article 13 of the TSCG and Protocol No 1 to the treaties.

I look forward to exchanging views on this matter and others when I go to the inter-parliamentary meeting on the European Semester on 30 January and in other contacts I have with national parliaments. Specific accountability procedures will, of course, have to be built in as appropriate to each new instrument or procedure that we develop as we deepen our Economic and Monetary Union.
