

POLICY SECTION 20 - 22 January 2013

The science section consists of three parallel parts, each with keynote speakers, oral and poster presentations.

PART I: Geopolitics in a Changing Arctic

PART II: Marine Harvesting in the Arctic

Scientific evidence is growing that indicates Arctic marine ecosystems are changing in response to increasing air and water temperatures and reduction in sea ice cover. Arctic species are experiencing increased competition from invasive temperate species. A changing Arctic ecology will challenge traditional harvest activities in the Arctic, while also providing new opportunities. Part II consists of the following two sessions:

SESSION 2 - Prospective harvest of marine biological resources in the Arctic

PART III: Arctic Marine Productivity

Arctic ecosystems are presently undergoing rapid climate - induced changes and these changes are expected to amplify in the coming decades. At the same time, human activities are increasing and this trend is expected to continue. The combination of changes in climate and human activities will alter the future structure and functioning of Arctic ecosystems. Part III focuses on ecosystem productivity and is structured around two themes:

THEME 1 - The patterns and processes controlling and structuring marine productivity today

THEME 2 - How these processes scale to the pan-Arctic domain and may change in a future Arctic
