Definitions

- Interparliamentary Committee Meeting (ICM):

Meeting organised under the sole responsibility of the European Parliament at committee level.

- Joint Committee Meeting (JCM):

Meeting hosted by the European Parliament, organised by the European Parliament jointly with the Parliament of the EU Presidency and co-chaired by the Presidents of the committees concerned.

- Joint Parliamentary Meeting (JPM):

Meeting hosted by the European Parliament, organised by the European Parliament jointly with the Parliament of the EU Presidency and co-chaired by the Presidents. These meetings deal with transversal issues involving more than one of the European Parliament's committees.
