Conclusion of the conference by Professor William A. Schabas

The International Criminal Court (ICC) is the first permanent, treaty based, international criminal court established to help end impunity for the perpetrators of the most serious crimes of concern to the international community.

In 1998, an historic milestone was reached when 120 States adopted the Rome Statute, the legal basis for establishing the ICC on the basis of common definitions of genocide, crimes against humanity and war crimes.

Ten years ago, on 1 July 2002, the ICC opened its doors. Today it is supported by 121 States Parties, with 15 individual cases, seven ongoing investigations in country situations and 12 outstanding arrest warrants.

The conference is held to mark the Court's tenth anniversary. The event will give practitioners and academics a unique opportunity to discuss results accomplished and challenges to be addressed. The list of speakers include prominent international experts.
