Invitation to an inter-parliamentary committee meeting of the European Parliament's Committee on Development with national Parliaments of the European Union's Member States on the issue of Policy coherence for development: how the European Parliament and national parliaments can work together

Dear Chair,

I am pleased to inform you that the European Parliament's Committee on Development will organise an inter-parliamentary committee meeting with national parliaments on Tuesday 23 April 2013, from 9h00 to 12h30, in the European Parliament's premises in Brussels on the issue of Policy coherence for development: how the European Parliament and national parliaments can work together.

Article 208 of the TFEU states that "The Union shall take account of the objectives of development cooperation in the policies that it implements which are likely to affect developing countries". This principle is commonly referred to as Policy Coherence for Development (PCD) which aims to ensure that the objectives and results of the EU and Member State governments' development policies are not undermined by other policies which impact on developing countries, and that these other policies support development objectives, wherever possible.

The European Parliament adopted in May 2010 a resolution on PCD¹ where it proposed to appoint a Standing Rapporteur for PCD with the mandate of following up incoherencies in EU policies and bringing them to the attention of the Committee on Development. Ms Birgit Schnieber-Jastram was appointed Standing Rapporteur on PCD and subsequently prepared an own-initiative report² on the Commission's "EU 2011 Report on Policy Coherence for Development" that will be adopted shortly in Plenary. The own-initiative report "Calls for the introduction of structured annual meetings between representatives of national parliaments of EU Member States and the European Parliament to ensure consistency in the spending of development aid" (Paragraph 8).
