Memorandum of Understanding between the Ministry of
Health and Global Medical Aid

This Memorandum of Understanding (hereafter referred to as MoU) is entered by and between the Secretary, Ministry of Health of Sri Lanka (Hereafter the Ministry) at 385, "Suwasiripaya", Baddegama Wimalawansa Mawatha, Colombo 10, Sri Lanka acting for and on behalf of the Republic of Sri Lanka being one part as the implementing agency

And

Global Medical Aid (hereafter GMA), Vandtårnsvej 38, DK 3460 Birkerød, Denmark

On the 18th October, 2011

Whereas, the purpose of this project is for the implementation of a project, for donating medicine and medical equipment from Denmark and distribute, freely to hospitals and medical camps in rural areas, where it is needed.

Whereas the Sri Lankan Government has expressed its intention for the above project, and to establish methodologies for implementation of the project as the decision taken at the discussion held on 21st June, 2010 among the Honorable Minister, Mr. Maithreepala Sirisena, Secretary to the Honorable Minister, Attorney at-Law, Mr. L.M. Gunasena, the Secretary to the Ministry of Health, Dr. Ravindra Ruberu, Attorney-President of Global Medical Aid Hans Frederik Dydensborg and Dr. Nimal Kariyawasam.

Whereas the parties hereby agree as below:

PROJECT AIMS AND OBJECTIVES

1. AIMS

- GMA will donate high quality medicine, donated from drug firms and useable medical equipment to needed patients, hospitals, and health camps in accordance with the GMA guidelines for drug donations (attached below as annexure I) and as per the terms of this MoU.

2. OBJECTIVES

- To establish a system to import the donated medicine and medical equipment to all parts of Sri Lanka.
3. All the medicines so donated should be registered under CDDA Act and in Sri Lankan Drugs Regulatory Authority. The safety, quality and efficacy of the drugs is to be ensured before using or distributing.
 4. All the equipment should conform to the Ministry of Health (CDDA/Biomedical) approved specifications. The Local Agents also should be declared with the equipment for warranty and after sales service as well. After warranty, separate agreement be entered with the Local Agent for maintenance.
 5. To clear and transport imported medicine and the equipment to the destinations by the Health Ministry using their transport facilities or by GMA.
 - The Medical Supply Division of the Health Ministry clear the medicine and the medical equipment and transport to the nominated destinations of hospitals and health camps and if there are any separation of medicine according to the relevant list will be done by the staff of the Medical Supply Department in their stores and distributed to the necessary places.
 6. To maintain the system as a sustainable entity
 - GMA will contact the doctors and the heads of the hospitals and the camps and allocate the medicine and medical equipment for the delivery. GMA will arrange the presentations and ensure the medicine will be distributed through the needed hospitals and the camps. If needed GMA will maintain the data bases to track down the usages of medicine throughour the country.

7. LEGAL IDENTITY OF THE PARTNERS

GMA, a non-political, non -religious and non-profit organization is registered in Denmark - CVR Number 33 31 92 31

8. DURATION

Project will commence 18th October, 2011 and continue unless and until the health authorities discontinue it in writing.

9. LAW

This MoU shall be governed by the laws of Sri Lanka.

10. FORCE MAJEURE

The parties to this MoU are not liable for incidents occurred due to force majeure.

11. FINANCES

Global Medical Aid in Denmark will bear the cost of air freight to Sri Lanka, Colombo Airport and Health Ministry will bear all the costs of clearing and transporting to the destination of hospitals and health camps. GMA will if possible try to get the costs refunded. Ministry of Health will bear the cost of any duty or tax involved.

(12) RESPONSIBILITIES

GMA AGREE TO THE FOLLOWING RESPONSIBILITIES:

1. Donation of all medicine and medical equipments are audited and made sure that it will be received by the hospitals before the expiry days as much as possible by contacting the receivers time to time.
2. Maintain the potential data bases and update according and ready to present at any inquires held by the required authorities.
3. Producing newsletters and reports and publish in necessary medias.
4. Not to publish any outcome information without the written approval of the Director General of Health Service or an officer authorized by him.
5. Provide all needed information with regard to the project to the Ministry of Healthcare and Nutrition when requested.
6. GMA will only donate medicine according to the list of needed medicine provided by the government of Sri Lanka.

13 MINISTRY OF HEALTHCARE AND NUTRITION HEREBY AGREE TO THE FOLLOWING RESPONSIBILITIES



1. Payment of duties, taxes, etc., if there is any, in order to clear the medicine and the medical equipment and accessories.
2. Ministry will be the formal receiver of the donations, but will on request issue a power of attorney to GMA for clearing the donations
3. Plan the project and provide necessary instructions with regard to the implementation of the project.
4. Monitor the project outcome continuously and make decisions accordingly.
5. Publish the outcome information if required.
6. The destinations are decided by GMA, advised by the Ministry of Health
7. GMA is entitled to donate to other countries and directly to other organizations and hospitals in Sri Lanka without any notice to the Ministry
