Dear Mr. President,

The Second International Conference on Nutrition (ICN2) will take place from 19 to 21 November 2014 at the headquarters of the Food and Agriculture Organization of the United Nations (FAO) in Rome, Italy. This high-level Conference will be the first world intergovernmental forum dedicated solely to the global nutrition problems of the twenty-first century. More information about ICN2 is available on its website at: www.fao.org/about/meetings/icn2/en/.

Notwithstanding the progress made in many countries, unacceptably high levels of malnutrition persist. More than a third of the world's population is adversely affected by malnutrition, in the form of hunger, "hidden hunger" (micronutrient deficiencies) and the diet-related non-communicable diseases often associated with obesity. Malnutrition in developed and developing countries alike impedes the full realization of human potential and imposes avoidable burdens on families and societies.

The aim of ICN2 is to put nutrition high on international and national development agendas. By collectively addressing the multiple burdens of malnutrition, the Conference will endeavor to ensure more effective international cooperation to deal with these challenges. The ultimate objective is to reach consensus on a global nutrition framework that will strengthen the commitment of countries to eliminate global hunger and prevent all forms of malnutrition.

I am pleased to invite members of your parliament who will be in Rome for ICN2 to take part in the Parliamentary Meeting on the theme *Parliamentarians for better nutrition*, organized by the IPU with the kind sponsorship of the Italian Parliament. The Meeting will take place on 18 November 2014 at 8:30 a.m. in Rome's *Sala della Protomoteca (Campidoglio)*.

I enclose the draft agenda, the concept note drawn up for the Meeting and the registration form. I invite your parliament to complete the registration form and return it to the IPU Secretariat by 8 November 2014.

Please note that the Parliamentary Meeting will take place before ICN2 and that registration will not grant access to the Conference itself. In order to attend ICN2, each delegate will have to register at <http://www.fao.org/about/meetings/icn2/information/registration/en/> where participants will also find helpful information about accommodation and visa requirements. Such logistical matters remain the sole responsibility of participants.

I sincerely hope that your parliament will be represented at the Parliamentary Meeting, preferably by parliamentarians directly involved in food security and nutrition issues. The IPU looks forward to welcoming them at the Parliamentary Meeting in Rome.

Parliaments for better nutrition

Concept Note

BACKGROUND

A high-level inter-governmental meeting, the Second International Conference on Nutrition (ICN2), jointly organized by the Food and Agriculture Organization of the United Nations (FAO) and the World Health Organization (WHO), will be held in Rome from 19 to 21 November 2014. Centred on the theme *Better nutrition for better lives*, the Conference will bring together senior national policymakers from food, agriculture, health and other relevant ministries and agencies, government officials, parliamentarians, senior representatives of the United Nations, other intergovernmental organizations, researchers, private sector and civil society representatives in order to motivate, mobilize and commit to policy priorities on how national and global food, health and related systems and reforms can improve nutritional outcomes.

The recent *The State of Food Insecurity in the World 2014* found that, while the number of people experiencing hunger was reduced by 100 million over the past decade, today, 805 million people remain chronically hungry, 161 million children are still stunted, acute malnutrition (wasting) affects 51 million children, 42 million children are overweight, and over 500 million adults are obese. Overall, throughout the planet, two billion people continue to suffer from various micronutrient deficiencies.

Through the *Rome Declaration on Nutrition* and its companion *Framework for Action*, expected to be adopted on 19 November 2014, senior policy makers assembled at the Second International Conference on Nutrition will collectively commit to eliminating global hunger and preventing all forms of malnutrition worldwide. They will also recommend to the United Nations General Assembly to endorse both the *Rome Declaration* and the *Framework for Action*, and to consider declaring a *Decade of Action on Nutrition* from 2016 to 2025, taking into account the post-2015 development agenda process. The *Rome Declaration* and the *Framework for Action* are available on the ICN2 website at: www.fao.org/about/meetings/icn2/documents/en/.

The political commitments set forth in the *Rome Declaration* will entail decisive and urgent action, including the development of national laws, policies, strategies, plans and programmes to enhance food systems, improve nutrition and ensure healthy diets. Greater efforts will also be needed to strengthen human and institutional capacities to address hunger and malnutrition, as well as to increase investments for effective interventions. Relevant UN bodies and other organizations, especially FAO and WHO, will be called upon to support governments in their national initiatives to eliminate hunger and combat malnutrition.

Strong engagement of parliaments will be crucial in ensuring that the necessary legislative tools on food security and nutrition are put in place. Thus, it is important that

they be actively involved in the global policy debate on food security and nutrition to secure their timely contributions, through their respective legislative bodies, in carrying out – at country level – the political commitments in the *Rome Declaration*.

IPU is tackling the issue of nutrition with its ongoing work with parliaments on maternal, newborn and child health (MNCH) as well as child rights. Particular attention is paid to law-making, oversight, and representation powers parliamentarians can deploy to help reduce malnutrition rates and thereby improve the health and development outcomes.

It is IPU's practice to organize parliamentary meetings in connection with major UN conferences and it would represent a continuum with the parliamentary meeting that was held on the occasion of the FAO World Summit on Food in November 2009. Also this year, on the occasion of ICN2, a Parliamentary Meeting will be organized on 18 November 2014, under the title: *Parliaments for better nutrition* – echoing the main theme of the Conference. Organized by the Inter-Parliamentary Union with the kind sponsorship of the Italian Parliament, this pre-ICN2 event will be hosted by the Municipality of Rome, in the Sala Protomoteca.

OBJECTIVE

- Provide information about the ICN2 and its expected outcome
- Articulate a parliamentary perspective on the key nutrition challenges and opportunities
- Identify parliamentary actions to support implementation of the ICN2 commitments
- Promote exchanges among parliamentarians on good parliamentary practice.

OUTCOME

- Sensitize participants to the importance of the national legal climate as an essential contributor to better nutrition
- Encourage participants to promote national dialogue, legislate, and conduct effective government oversight to advance the progress under the ICN2 commitments.

The outcome of the Parliamentary Meeting will be reported in a statement to the ICN2 on 21 November, and will be included in the final report of the Conference.

PARTICIPANTS

The Parliamentary Meeting is intended for members of parliaments worldwide. Invitations addressed to the Speakers of national parliaments are intended to inform of the Meeting all parliamentarians who will attend the ICN2 as part of their national delegation and facilitate their participation in the Meeting.
