6. <u>Election of the Secretary General of the OSCE Parliamentary Assembly</u>

The PRESIDENT informed the Standing Committee of the proposal of the Bureau to elect Mr. Roberto MONTELLA as Secretary General of the OSCE Parliamentary Assembly.

The PRESIDENT accordingly declared Mr. Roberto MONTELLA elected as Secretary General of the OSCE Parliamentary Assembly for a period of five years beginning on 1 January 2016.

8. <u>Supplementary Items</u>

Because of the absence of the Russian delegation, two of the supplementary items were no longer valid. A number of amendments were also likely to fall for the same reason.

The proposed distribution of the remaining supplementary items between Committees had been circulated. The PRESIDENT reminded the Standing Committee that under the Rules of Procedure, a majority of two-thirds was required to add an item to the agenda, and a simple majority was required on questions of allocation.
