Judge at Hof local court (guardianship and estates matters) in 2005; judge at Hof regional court from 2005 to 2007 (civil matters); public prosecutor at the Hof public prosecution office from 2007 to 2009 (general offences, juvenile delinquency, child pornography); parental leave from 2009 to 2010; judge at Hof regional court since January 2011 (general civil matters, medical and legal malpractice liability, capital investment cases).
