The **Association of Friends of the Sahrawi People of Seville (AAPSS)**, supported by The State Coordinator of Sahara Solidarity associations (**CEAS – Sahara**), has taken the commitment to organize the “**3rd European Conference about Information in the Western Sahara**”. The city of Seville has been chosen because it is an emblematic city with a long Spanish-Arab architecture tradition that represents an unbeatable hosting venue.



The new edition of the European Conference about Information in the Western Sahara, has the approval of the 40th EUCOCO held in Madrid in 2015. It is justified by the need of discussions and actions to promote the Information about the Western Sahara. It is necessary to counteract the Misinformation from Morocco’s government and the consequences of their occupation of the Sahrawi territory.

Seville, capital of **Andalucía**, this area is located at the South of Spain and approximately 14 Km from Morocco. It is a welcoming city with a privileged situation close to the Guadalquivir River. Sevilla has excellent transport links thanks to its international airport, rail network and public transport. The city offers plenty of accommodations, services, bars and restaurants.



### **Information as weapon for Western Sahara Freedom**

Morocan's rupture with UN together with their pieces of insolence to the Secretary General **Ban Ki-Moon** have brought the tragedy to Sahrawi People and harden repression on Occupied Territories of Western Sahara over civilian Sahrawi Population.

The international movement of solidarity with Sahrawi People has the main goal to give publicity to the situation, so that the suffering of this dignified people is known and spread and won't be forgotten from collective memory. Specially in a moment like this, **No Peace, No war**

The European Conference about Information in the Western Sahara must analyse the last report of UN Security Counsel from **April 2016** and act accordingly.

This is leading us to adopt cooperation agreements, to coordinate and to use information channels needed to break the misinformation imposed by the interests of big public and private communication lobbies.

Therefore there is a need to build an **international debate forum**. It must take stock of the results obtained so far and adopt new compromises to coordinate and establish future targets taking into account the evolution of the conflict of the Moroccan occupation of the Western Sahara.
