Subject: Pettiton to plead the European Parliament to postpone any decision to restore GSP+ to Sri Lanka

We, the representatives of Danish Tamils, are signing this petition to plead you, the Danish Government and the EU Parliament, to postpone the granting of GSP+ to Sri Lanka (SL) until the Government of Sri Lanka (GOSL) has proved that they have addressed the shortcomings raised by the EU in 2010 when the GSP+ was withdrawn and satisfactorily resolve all the issues raised in UNHRC Resolution, adopted at the 30th session of the HRC, which the GOSL had co-sponsored.

As noted in European Commission's Report¹ on assessment of the application for GSP+ by Sri Lanka [European Commission, 2017], the GSP+ aims to support vulnerable developing countries such as Sri Lanka "to assume the special burdens and responsibilities resulting from the ratification of 27 core international conventions on human and labour rights, environmental protection and good governance, as well as from their effective implementation." The report further states ".... the shortcomings do not amount to a serious failure to effectively implement the Convention that would prevent Sri Lanka from joining the GSP+", under section 4.D (Point 12).

This assessment seriously undermines the reality. Six years after the withdrawal of GSP+, and despite the change in government, torture has remained disturbingly persistent in Sri Lanka. Following a comprehensive review, the pre-eminent UN body for addressing torture, described torture as "common practice" in Sri Lanka [United Nations Human Rights Council, 2016] (The New York Times, 07/12/2016), the result of long-standing impunity for perpetrators combined with a failure to undertake basic institutional reforms to deter its use.

Acknowledging the credibility of various reports by human rights organisations concerning ongoing abductions and torture under the new government, as well as the continued existence of secret detention sites used to facilitate them, the Committee made a series of 50 recommendations along with a request for the Government of Sri Lanka to provide a further implementation report by 7 December 2017.

The new President and his regime are still refusing to set-up a credible investigation and conscious resolution, which Sri Lanka signed up to in UNHRC. The government has also rejected the recommendation of the President's own Consultation Task Force on Reconciliation Mechanisms, as the Government spokesman Dr. Rajitha Senaratne said "the government is clear in its stand that a purely domestic mechanism will be used to investigate incidents related to the war while foreign technical assistance will be used if required." [Easwaran Rutnam, 2017].

We urge you to postpone any decision to restore GSP+ to Sri Lanka until the UN Committee Against Torture has evaluated this report, Sri Lanka has addressed all the issues highlighted in (their co-sponsored) UNHRC Resolution and addressed all the shortcoming raised by EU in 2010. To determine the issue any sooner would not merely fly in the face of the EU's own advice on the matter; it would also seriously undermine the important work of the Committee and represent a grave affront to the survivors of torture.
