(legal and practical)?	
2) Administrative Cooperation between Member States authorities under Dublin: what works? co-chaired by MEP and NP, speakers: EASO and representative(s) of national authorities (tbc) <b>Questions for written answer</b> a) In your country, are there different authorities responsible for the assessment of asylum claims and for Dublin transfer assessments? b) In your experience, what are the main difficulties (legal or practical) faced by asylum authorities in the implementation of the Dublin system? c) According to your experience, what are the main challenges of the current distribution system affecting your administration?	
3) Legal assistance and alternatives to detention during the asylum procedure: Exchange of good practices from Member States, co-chaired by MEP and NP, speakers: CoE, International Detention Coalition (tbc) <b>Questions for written answer</b>
