I write to you in my capacity as Co-Chair of the Joint Parliamentary Scrutiny Group on Europol (JPSG). Thank you for your letter of 21 May 2018 in which you informed the Co-Chairs that you have been mandated to continue discussions.

At the JPSG Meeting of 18-19 March 2018, it was announced that a JPSG working group on the representation of Denmark in JPSG meetings would be set up.
