

36.7 MILLION PEOPLE GLOBALLY LIVE WITH HIV (end of 2015)

2.1 MILLION ARE ADOLESCENTS

ADOLESCENT GIRLS AND YOUNG WOMEN FACE GENDER-BASED INEQUALITIES, EXCLUSION, DISCRIMINATION AND VIOLENCE

240 MILLION PEOPLE ARE THOUGHT TO BE CHRONICALLY INFECTED WITH HEPATITIS B AND 184 MILLION PEOPLE HAVE ANTIBODIES TO HEPATITIS C

VIRAL HEPATITIS IS RESPONSIBLE FOR ~ 1.4 MILLION DEATHS PER YEAR

OVER 10 MILLION PEOPLE DEVELOP TUBERCULOSIS (TB) EACH YEAR

IN 2015, THERE WERE AN ESTIMATED 1.4 MILLION TB DEATHS AND AN ADDITIONAL 0.4 MILLION DEATHS RESULTING FROM TB AMONG PEOPLE LIVING WITH HIV

An independent charity (nonprofit, non-partisan, NGO) with funding from non-health industry sources


Political representatives from around the world to give a coordinated, effective and strong response towards eliminating these global threats


