Excellency,

The review and appraisal of the Programme of Action of the International Conference on Population and Development (ICPD) and its contribution to the follow-up and review of the 2030 Agenda for Sustainable Development will be the main theme of the 52nd session of the Commission on Population and Development in 2019. The Regional Commissions and other United Nations system agencies are requested to contribute and provide inputs to the report by the Secretary-General on this occasion. The regional inputs should draw on the five-year progress assessment in the follow-up to the outcome documents of the ICPD beyond 2014 regional review conferences.

The periodic progress assessment in the UNECE region is currently being carried out by UNECE and UNFPA as part of the project Enhanced integration of population dynamics into development planning: follow-up to the ICPD in the UNECE region. The assessment will conclude with the UNECE Regional Conference on ICPD@25 on 1-2 October 2018 in Geneva. The title of the Conference is "Enabling Choices: Population Dynamics and Sustainable Development". The Conference will focus on key actions for implementation, highlighted in the Chair's summary of the regional ICPD Beyond 2014 conference, and address the wider policy concerns related to population dynamics and sustainable development; families, sexual and reproductive health over the life course; and the need to ensure social inclusion and rights and reduce inequalities in line with the 2030 Agenda for Sustainable Development.

The regional report and conference outcomes will inform the global review of the ICPD which will take place at the 52^{nd} Session of the UN Commission on Population and Development.

To achieve these objectives, the Conference expects to draw on strong representation from governmental authorities including high-level officials, leading experts on population issues, key civil society and other stakeholder organizations at national and international levels active in this field as well as those involved in multidisciplinary research.

UNECE Regional Conference on ICPD@25 Enabling Choices: Population Dynamics and Sustainable Development

Geneva, Palais des Nations, 1-2 October 2018 Organized jointly by UNECE and UNFPA

CONCEPT NOTE

BACKGROUND

In 2014, the international community reviewed progress on 20 years of implementation of the Programme of Action of the International Conference on Population and Development (ICPD) at national, regional and global levels. The regional reviews were led by the United Nations Regional Commissions in close collaboration with the United Nations Population Fund (UNFPA). Their outcomes contributed to the global review of the ICPD Beyond 2014, which took place at the 47th session of the Commission on Population and Development (CPD) and culminated in the 29th Special Session of the United Nations General Assembly in September 2014.

In its Resolution 2014/1, the CPD emphasized that the outcome documents of the regional conferences provide region-specific guidance on population and development beyond 2014 for each region. They requested the Secretary-General, in collaboration with the United Nations system and relevant organizations, to continue assessing and reporting on progress towards the full implementation of the Programme of Action of the ICPD.

In the UNECE region¹, the ICPD beyond 2014 review concluded with the UNECE Regional Conference *Enabling choices: Population Priorities for the 21st Century* (1-2 July 2013, Geneva). The UNECE regional report and the ICPD beyond 2014 Chair's summary, which was the unanimously agreed outcome of the Conference, outlined the main findings and recommendations for the way forward. Now, five years later, and within the context of the joint project *Enhanced integration of population dynamics into development planning: Follow-up to the ICPD in the UNECE region*, the UNECE Population Unit and UNFPA Eastern Europe and Central Asia Regional Office are working with member States, civil society partners and other stakeholders to assess progress made, identify challenges and gaps in implementation and prepare a regional report for the UNECE region on ICPD@25, based on the ICPD beyond 2014 Chair's summary and its monitoring framework.

The UNECE Regional Report on ICPD@25 will be launched at the UNECE Regional Conference Enabling Choices: Population Dynamics and Sustainable Development, on 1-2 October 2018, which will conclude the five-year periodic assessment.

PERMANENT MISSION OF THE REPUBLIC OF CHAD

Excellency,

The Permanent Mission of the Republic of Chad to the United Nations Office in Geneva and the United Nations Economic Commission for Europe (UNECE), which provides the secretariat to the Convention on the Protection and Use of Transboundary Watercourses and International Lakes (Water Convention), have the honour to invite you to a high-level ceremony to celebrate the accession of the Republic of Chad to the Water Convention

The Convention, which entered into force in 1996, represents the only United Nations legal and intergovernmental framework promoting the quantity, quality and sustainable use of transboundary water resources by facilitating cooperation. Originally negotiated as a regional framework for the pan-European region, following its amendment, the Convention is open for accession by all United Nations Member States since 1 March 2016. Chad was the first country outside the pan-European region to accede to this instrument in February 2018.

The ceremony will take place on Tuesday 29 May 2018 from 9:00 to 10:30 in Room XXIV of the Palais des Nations in the presence of the Minister of Environment, Water and Fisheries of Chad.

The ceremony aims to share the experience of Chad's accession process together with the rationale and benefits derived thereby. The ceremony will also allow sharing views from Parties on the globalization of the Convention and from countries which have started or consider starting a national accession process.

The ceremony will take place in the margins of the joint meeting of the Working Group on Integrated Water Resources Management and the Working Group on Monitoring and Assessment under the Water Convention (28 to 30 May 2018) which will discuss the preparations for the eighth session of the Meeting of the Parties (Astana, Kazakhstan, 10 to 12 October 2018).

We hope that you will join us in celebrating this important step in the global opening of the Water Convention. For planning purposes, please confirm your attendance no later than 20 May to: water.convention@un.org.
