Re. Zimbabwe Jylland Honorary Consul Proposal.

Honourable Zimbabwean Director of Protocol, Legal and Consular

and

Honourable Minister of Foreign Affairs in Denmark

I would like to bring to your attention a proposal to establish an honorary Zimbabwean consulate to based in Jylland, for the sole purpose of furthering the development of commercial, economic and scientific relations between Zimbabwe and Denmark, otherwise promoting friendly relations between them in accordance with the provisions of article 11 of the Vienna Convention on Consular Relations 1963.

Mugabe is gone and now more than ever, Zimbabwe and Denmark could mutually benefit from each other. I am willing to work hard, even without a government budget to convince Danish companies and organisations in Jylland to invest and do business in Zimbabwe.

Therefore, I need consent from both the Zimbabwean Ministry of Foreign Affairs and the Danish Ministry of Foreign Affairs.

In the meantime, I have also reached out to the majority of Mayors in Jylland and I am confident of their endorsement as a Zimbabwe Jylland based consulate would promote mutually beneficial business interests.

I have lived in Denmark for 7 years and I was an official guest of the government through the City of Aarhus. I have a Danish partner and child. I have recently studied Conflict Analysis with UN Peace University. I have also written several books and written for several Danish, International and Zimbabwean newspapers. I also have entrepreneurial experience in Denmark and Africa as I organised for the importation of coffee to Denmark from the Bob Marley family in Jamaica. In Zimbabwe I worked as banker and in Namibia I was a Business consultant for many years, before being invited to Denmark in 2010. All this is available online. I have also worked with radio and television in Jutland and in 2012 I became won the Special Jury Price at the French Riviera Nice Film Festival for the animation film, A Can of Worms, which is based on my book, Mugabe Must Go.

I am a young Zimbabwean and with the coming leadership of president E.D Mnangagwa, I would like to serve the people of Zimbabwe in the capacity of Honorary Consul to Jylland and I hope this proposal is acceptable to both of you.

Now is the time for better Zimbabwe-Danish relations and I want to be heavily engaged in that process to serve both Zimbabwe and Denmark.
