Folketingets Social-, Indenrigs- og Børneudvalg har d. 25. oktober 2017 stillet følgende spørgsmål nr. 46 (alm. del) til børne- og socialministeren, som hermed besvares.

Spørgsmål nr. 46:

”Vil ministeren oversende en oversigt over procentsatsen for forældres egenbetaling i vuggestuer og børnehaver i de enkelte kommuner i hhv. 2016, 2017 og 2018?”

Svar:

Kommunernes fastsatte forældrebetalingsandel for en plads i kommunale og selv-ejende daginstitutioner er gengivet i tabel 1 nedenfor for årene 2016 og 2017. Det er ikke muligt på nuværende tidspunkt, at oplyse om forældrebetalingsandelen i 2018, idet kommunerne i henhold til dagtilbudsloven har frem til den 1. december til at fastsætte og offentliggøre takster og tilskud for 2018.

Forældrebetalingsandelen er fordelt på børn i aldersgruppen omkring 0-2 år og i aldersgruppen omkring 3 år-skolestart. Den enkelte kommune beslutter den konkrete aldersfordeling for tildeling af kommunens tilskud og opkrævning af forældrenes andel af de samlede bruttodriftsudgifter ved en plads.

Endvidere bemærkes, at den enkelte kommune beslutter, om frokost i daginstitutioner skal indgå som en del af den samlede plads, eller forældrene skal have mulighed for frokost ud over pladsen i daginstitutionen, og med mulighed for fravalg.
