As a general rule, an applicant must have at his/her disposal approx. DKK 350 per day. We need the proof of pocket money before the 15 days deadline for case handling ==> starting the day the application was lodged at the Embassy. If we have not received the proof – we will take the decision on the basis of the information/documents provided.

Dear Nameless Visa Desk Officer,

I am copying this mail to the ministry's general mail adresse, since I am no longer knowledgeable about who is in charge of overseeing the affairs of the embassy in Mali, since I am highly disturbed about the unprofessional responses received or rather lack of response on my many calls and mail to the consulate, which never identifies the person in charge of a case. It is obvious to me, that the rules which applies for Danish public services in Denmark, do not apply for Danish representation abroad, and they also seem to have changed since I worked in the Ministry of Foreign Affairs.

First of all I wish to let you know that I do not consider your communication to be in line with what normally is expected from a Danish Authority, but I wish nevertheless to reply to your mail. Please, let me know if you doubt that I will be unable to provide my wife's mother with adequate pocket money, while she will be staying with us. If this should be the case, kindly let me know how I can submit proof of the capacity to satisfy your formal demands, which in fact we do satisfy. Secondly, I fail to find any evidence on the need to make an insurance, which covers beyond the period of her stay here. Allow me to quote from your link: Travel insurance covering the entire Schengen area which is alid for the expected duration of your stay. Please let me know how to satisfy your demand, by stating number of days or other requirements, not easily identifyable in your regulations.

It would much be appreciated, if you would be nice enough to identify the text which has caused you to call upon my Mother-in-Law on a number of occasion. In fact, I have tried to call upon you many times, and left a message on a voice mail, but seemingly to no avail.

In my invitation, I have stated that I take charge of all expenses related to Mrs. Badiane's stay with us. This included also her pocket money. I did call upon the authorities here in Denmark, Udlændingestyrelsen, to seek clarification. But it seems that you may hold information, which is not easily found here. Tomorrow, I will again call upon Udlændingestyrelsen to learn about the exact requirements to insurance for applicants to visa for Denmark.

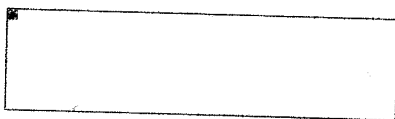
