Dear colleague,

Following my previous letter regarding the large-scale airborne, missile and land attack by Azerbaijan along the entire line of contact with Artsakh (Nagorno-Karabakh), I deem it essentially important to inform you on the grave developments taking place on the ground.

The reasonable doubts on the first days of Azerbaijani aggression about Turkish direct military involvement in Nagorno-Karabakh turned to be real. It is already proved by various facts that Turkey is actively engaged in the conflict, orchestrating actions of Azerbaijan's leadership both in military and diplomatic dimensions. Following the statements and actions of Erdogan's regime regarding to Nagorno-Karabakh it becomes clear that Turkey continues Ottoman Empire's genocidal intend.

Moreover, Turkey is sending mercenaries to the armed conflict zone from Turkish-controlled territories of Syria, as well as from Libya. Several countries have confirmed on an official level the involvement of foreign terrorist fighters from the Middle East. According to the growing number of reports the Jihadi fighters have been identified as belonging to such terrorist structures as Jabhat al-Nusra, Firkat al-Hamza and Sultan Murad.

I would also like to draw your attention on another absolutely appalling and unacceptable fact that the Azerbaijani armed forces are using heavy artillery, UAVs and multiple rocket launchers with cluster shells prohibited by the Convention on Cluster Munition against civilians. The use of such deadly weapons as cluster bombs as indiscriminate weapons are banned by international humanitarian law under any circumstances. The fact that Azerbaijani forces use cluster munitions has been also independently verified by the Amnesty International.

The heavy shelling of peaceful settlements inhabited by Armenians has an aim to ensure the exodus of Armenians from Nagorno-Karabakh and is an inhumane consequence of state-supported anti-Armenian policy of Azerbaijani authorities.

People of Artsakh have undeniable right to exercise all necessary measures of self-defense protecting themselves from genocide threat. International community must acknowledge that the frontline in Nagorno-Karabakh is becoming a civilization forefront. We are fighting against international terrorism, which, as you know, poses an equal threat not only to regional, but global security.

To conclude, I call you personally and your Parliament to take immediate, concrete and effective actions to sober military-political leaderships of Turkey and Azerbaijan.
