on the current situation in Ukraine - position of the Chamber of Deputies on the situation in Ukraine and the massacre in Bucha

the Chamber of Deputies

I. notes, that:

1. the Russian Federation has committed the crime of aggression against Ukraine, has unleashed a large-scale and unprovoked war in Europe, strives to destroy the rules-based international order, and is attacking freedom, liberal democracy and Western civilization based on respect for the human and civil rights of every individual,
2. the Russian leadership has lost all credibility and must be held accountable for its actions,
3. the murders of civilians in Bucha and other Ukrainian cities constitutes a war crime under international law,
4. the kidnapping of people from occupied Ukrainian territory into the Russian Federation, the targeted attacks against civilian infrastructure and the behavior of the Russian military is unjustifiable,
5. the drafting of conscripts into the Russian army in the occupied territories of Ukraine, including Crimea, is also in flagrant violation of international law,
6. the aggression against Ukraine, which the Russian Federation committed in 2014 by occupying Crimea and part of the territory of eastern Ukraine, also constitutes a crime,
7. all those responsible for these crimes must be brought to justice and punished,
8. the Russian Federation must bear the consequences for unleashing the war, including the payment of reparations;

II. supports the actions taken so far by the Government and the Ministry of Foreign Affairs, and **calls for**

1. intense support for Ukraine and the international community in documenting the crimes committed by the Russian Federation on the territory of Ukraine, and the involvement of the Czech Republic in the preparations for the establishment of an international tribunal to bring all the perpetrators to justice,
2. promoting further sanctions against the Russian Federation, that shall be escalated until Russia withdraws its troops from the entire territory of Ukraine, including Crimea,
3. urging for the withdrawal of all Russian troops also from the territory of Moldova, Georgia and Belarus,
4. enforcing a permanent ban on the export of arms, dual-use goods and any other technology usable for the Russian arms industry,
5. adoption of measures leading to the raw material independence of the Czech Republic and the entire European Union from the Russian Federation, so that revenues from the sale of Russian oil, natural gas and other raw materials cannot be used to finance further military aggression and subversive activities against the West,
6. other activities preventing Russian intelligence activities in the Czech Republic and the European Union that aim at destroying the values on which our freedom and prosperity and that of our allies are based,
7. a thorough investigation into the origin of the funds used by citizens of the Russian Federation to purchase real estate and other assets in the Czech Republic,
8. support for all Russians and Belarusians who oppose the Kremlin's criminal war against Ukraine, including support for those who have fled these countries,
9. further support for Moldova and Georgia, which are threatened by the presence of Russian troops on their territory,
10. further coordination within the European Union and with NATO allies, in particular the US and the UK.
