

Memorandum of Understanding
Between the State Administration for Market Regulation of the People's
Republic of China and the Ministry of Food, Agriculture and Fisheries of
Denmark
On the Cooperation of On-site Inspection of Recipe Registration of Infant
Formula Milk Powder During the COVID-19 Pandemic

The Ministry of Food, Agriculture and Fisheries of Denmark and the State Administration for Market Regulation of the People's Republic of China (SAMR);

In view of the long-term friendly relationship between China and Denmark, and in order to further strengthen the cooperation within the area of infant formula food safety, have reached the following understanding through friendly negotiation:

Purpose and Area of Cooperation

1. SAMR invites the Ministry of Food, Agriculture and Fisheries of Denmark to help to carry out the on-site inspection for the Danish companies that should meet the following conditions: the company already obtained the infant formula recipe registration in China (except the one whose products failed to pass the sampling inspection); and the company applied to SAMR for new recipe registration or recipe's substantial change registration; and the recipe to be registered has already passed the technical assessment organized by SAMR.
2. The on-site inspection will be carried out by Ministry of Food, Agriculture and Fisheries. The designated competent authority is the Danish Veterinary and Food Administration.


