- Under the new Governance rules, Member States would have greater room for manoeuvre in setting their budgetary adjustment path, reinforcing national sovereignty over their fiscal paths. Economic policy decisions are subject to voluntary coordination at the European level, with the result that decisions or economic developments in one member country strongly affect the other member states and can produce a contagion effect. To guarantee macroeconomic stability and the good function of the EMU, a fiscal discipline framework that promotes the sustainability of finances is essential.*
