Dear colleagues!

I would like to express to the Embassy and the Parliament of the Kingdom of Denmark and you personally my highest consideration and sincere gratitude for the consistent support of the State Border Guard Service of Ukraine in the face of russian aggression.

The State Border Guard Service of Ukraine, together with other forces of the security and defense sector of Ukraine, daily confronts russian aggression, protecting our country, democratic human and European values.

The full-scale russian military aggression against Ukraine has been going on for more than two years. The border guards have been fighting the russian invaders in the most difficult areas around the clock, showing true courage and heroism.

In order to provide combat units of brigade-type border guard detachments, joint detachments of border guard bodies, border guard commandant's offices of rapid response, which perform missions in the field and deploy field canteen facilities, with water of adequate quality for cooking and partial satisfaction of the drinking needs of personnel, there is a need to additionally provide field water purification systems of various capacities, namely:

- Bluebox 1500 UF Sand - 20 units;
- Bluebox 60 RO - 438 units;
- Bluebox 70 RO - 2 units;
- Bluebox 30 RO - 132 units;
- Bluebox 150 RO Wall - 24 units;
- Bluebox 6000 UF - 60 units;
- Bluebox 450 RO - 70 units.

At the same time, given the intensity of usage of these filtration systems and the standardized efficiency of the filter elements, there is a need to provide these systems with a supply of cartridges (filter elements) for a year, namely:

for Bluebox 1500 UF Sand - 1920 units;

for Bluebox 60 RO - 31536 units;

for Bluebox 70 RO - 48 units;

for Bluebox 30 RO - 9504 units;

for Bluebox 150 RO Wall - 2880 units;

for Bluebox 6000 UF - 8640 units;

for Bluebox 450 RO - 5040 units.

In view of the abovementioned, the State Border Guard Service of Ukraine would like to ask you to consider the possibility of providing water purification equipment for usage in the field conditions.

I avail myself of this opportunity to renew to the Embassy and the Parliament of the Kingdom of Denmark and to you personally the assurances of my highest consideration and to assure you that your support is extremely important and brings Ukraine closer to victory over the aggressor every day!
